Energen Resources Corporation requests administrative approval of an unorthodox location and non-standard proration unit for its Carson #208 well under the provisions of NMOCD R-8768.

The proposed well is to be located 1,635' FNL & 860' FWL of Section 19-T30N-R4W, Rio Arriba County, New Mexico and dedicated to a non-standard gas spacing unit consisting of the W/2 of said section 18, in the Basin Fruitland Coal gas pool.

The E/2 of section 18-T30N-R4W is dedicated to the San Juan 30-4 Unit (approved by the NMOCD), which provides in part that wells drilled to the Mesaverde and shallower formations shall be dedicated to E/2 or W/2 drilling blocks. Section 19 is irregular in size with the W/2 being made up of Lot 1 (NW NW) 14.82 acres, Lot 2 (SW NW) 14.86 acres, Lot 3 (NW SW) 14.90 acres, Lot 4 (SW SW) 14.94 acres, and E/2 W/2 totaling 219.52 acres which is less than 70% of 320 acres (219.52/320=68.60%) as required in the Basin Fruitland Coal Pool Rule 5.

For geologic reasons the subject well is to be drilled at an off pattern location so that it can stay within the overpressure envelope boundary which would not be obtainable at the closest standard location. See attached geologic narrative and map.

To stay within the overpressured envelope and minimize disturbance to wildlife and vegetation; we are proposing to situate the subject well on the existing well pad for Energen's Carson #4 well, located 1,561' FNL & 946' FWL of said Section 19.







Summary:

The Carson #208 has been staked in the nw/4 of section 19 because of geologic reasons. Based on our current interpretation of the Fruitland Coal overpressured envelope boundary, a well drilled at the standard location in the sw/4 is expected to encounter low permeability coal and would probably result in an uneconomic well.

Discussion:

The Carson #208 has only one objective, the overpressured Fruitland Coal. At this time, there are no commercial Fruitland Coal wells in T30N-R4W. Energen is attempting to extend the commercial production from the west into this township, but there is significant risk associated with this drilling program.


The overpressured envelope boundary is interpreted to run NE-SW through section 19. The standard location in the sw/4 of section 19 is interpreted to either be out of the overpressured envelope, or very close to the edge (see attached map). The coal near this boundary has very low permeability. This tight coal is what forms the trap (seal) for the overpressured envelope. Wells drilled in this tight coal are typically non-commercial.

Even the location in the nw/4 of section 19 has risk associated with it, as this low permeability coal area can extend over a mile away from the overpressured envelope boundary. However, because the nw/4 is farther away from the boundary, the risk is lower than the sw/4.

The interpreted location of this boundary is based on Fruitland Coal BHP data, gas composition, and non-commercial wells (see attached map).


