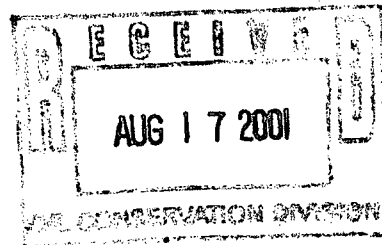

Concerning the above application dated July 15, 2001; I have attached a map showing the offset operators to the subject acreage and an original signed waiver from each operator.

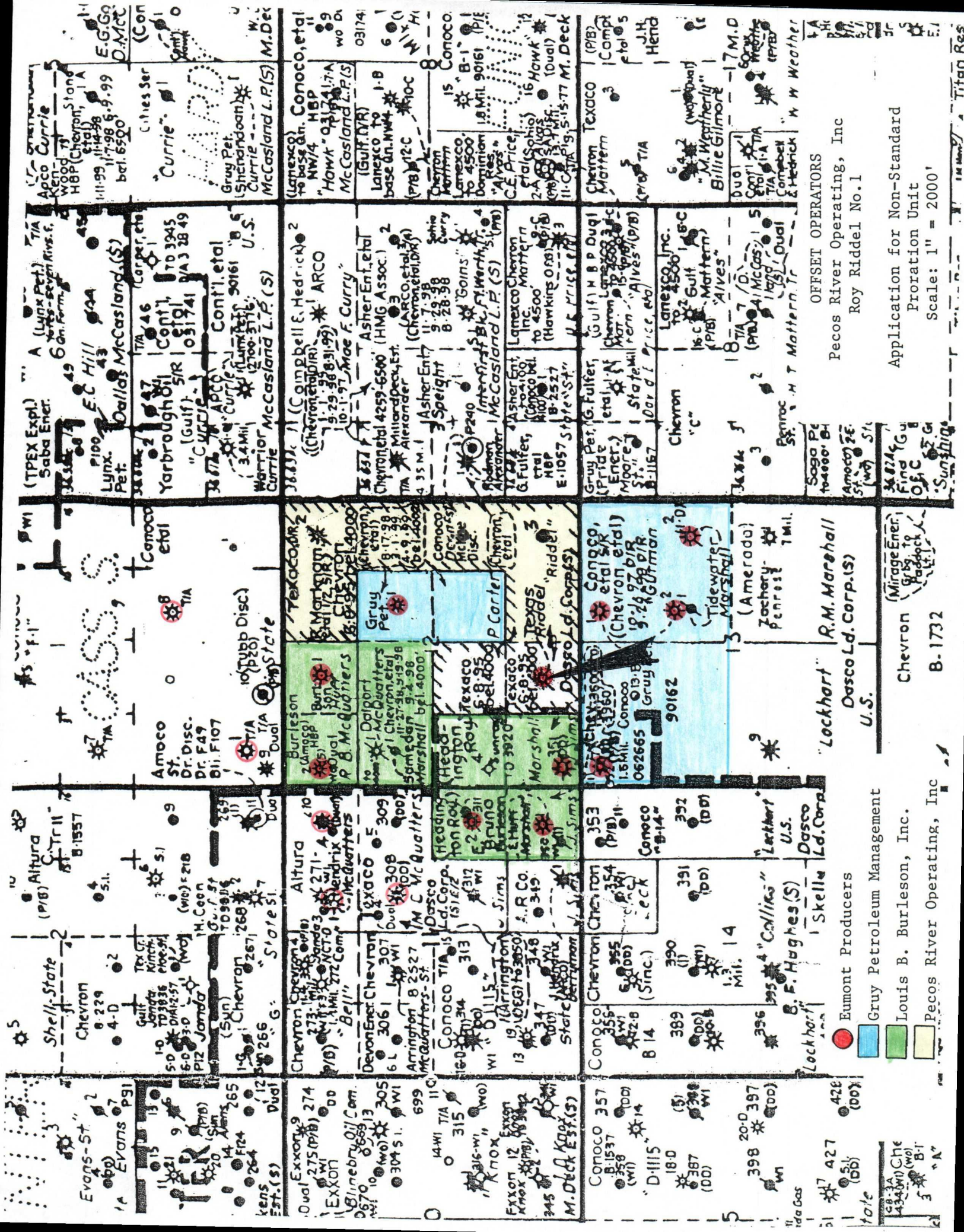
Of interest is the fact that the requested proration unit covers all of Pecos' interest, and is the only un-dedicated acreage in the SW/4 of Section 12.
