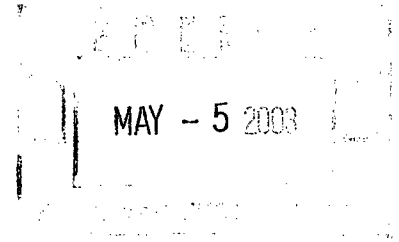



Dear Mr. Stogner:

Burlington Resources is applying for administrative approval of an unorthodox gas well location for the LaJara Pictured Cliffs, Blanco Mesaverde and Basin Dakota. The subject well is planned as a Pictured Cliffs, Mesaverde, Dakota trimingled completion and DHC-3105 has been approved on February 6, 2003.

The subject well was staked at this location due primarily to concerns with proximity to a tribal sacred peak, extreme topographic relief, several archaeological sites including those all along the road north of the subject location, and drainage from existing Mesaverde wells. The steep cliffs and rugged terrain of the sacred peak are shown on the attached aerial photograph and topographic map, which also shows the pipeline crossing the southwest quarter of Section 33.

The San Juan 30-6 Unit #424 Basin Fruitland Coal well is located at 1450'FSL, 1460'FWL in Section 33. This wellpad cannot be utilized due to its proximity to the San Juan 30-6 Unit #93 (30-039-77250) Blanco Mesaverde well located at 1800'FSL, 1650'FWL of Section 33.

Production from the Dakota is to be included in a 320 acre gas spacing and proration unit comprising of the west half of Section 33.

Production from the Mesaverde is to be included is a 320 acre gas spacing and proration unit comprising the west half of Section 33 and is dedicated to the San Juan 30-6 Unit #93 (30-039-07725) located at 1800'FSL, 1650'FWL of Section 33 and the San Juan 30-6 Unit #93A (30-039-25806) located at 1655'FNL, 880'FWL.

Production from the Pictured Cliffs is to be included in a 160 acre gas spacing proration unit comprising of the southwest quarter of Section 33.
