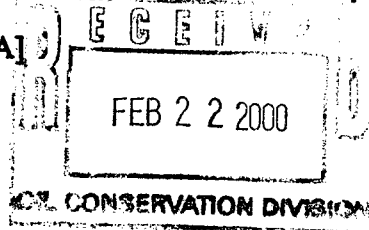

Attached is a copy of an administrative application for NMOCD approval for an unorthodox well location.

With your approval it is our intention to recomplete the Alice Paddock # 8 as a gas well in the Tubb reservoir. The subject well was originally drilled to and produced in the Wantz Granite Wash pool as a standard well location. The proposed recompletion to the Tubb would create an unorthodox well location. If approved the well will be produced as part of the Tubb Oil & Gas field.

Upon completion the subject well would be simultaneously dedicated with the Alice Paddock # 3.

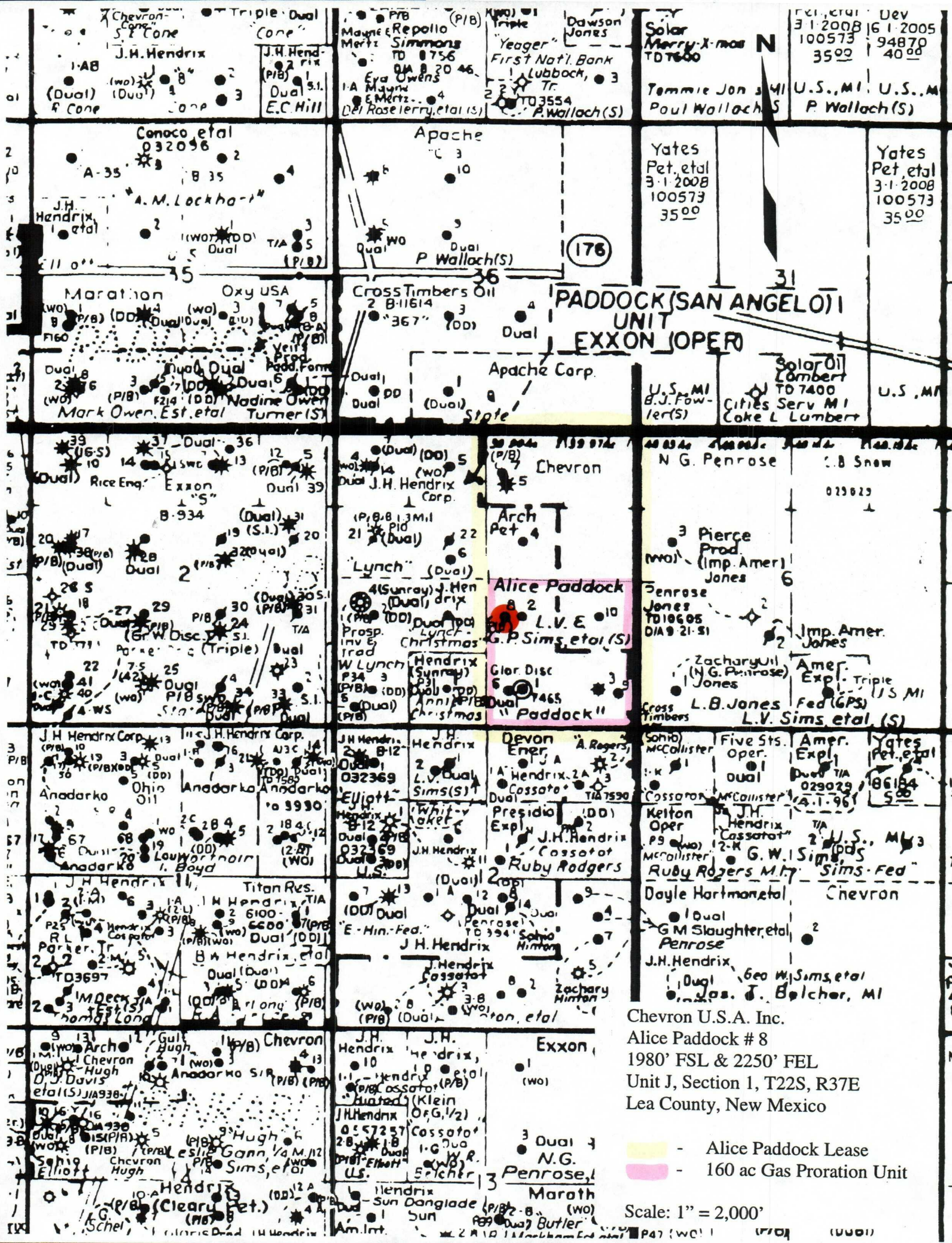
