The above named company is hereby authorized to commingle Saunders-San Andres (Oil 96196) Pool production from the following Lea County, New Mexico leases;

Amerada State Well No. 1 located in the SW/4 SW/4 of Section 4, and the
State "T" Well No. 2 located in the NW/4 SE/4 of Section 5;
all located in Township 15 South, Range 33 East, NMPM, Lea County, New Mexico.

Oil and gas production shall be separately and continuously measured for each lease. Water production shall be determined by periodic well tests.

Production shall be commingled on the State "T" Battery located in, Section 5, Township 15 South, Range 33 East, NMPM, Lea County, New Mexico.
