*Administrative Order SD-02-02*

Dear Mr. Hartman:

Reference is made to the following: (i) your application submitted to the New Mexico Oil Conservation Division ("Division") on August 15, 2002 (*application reference No. pKRV0-223138129*); and (ii) the records of the Division in Santa Fe, including the file on Division Administrative Order NSP-1631: all concerning Doyle Hartman's request for a second Eumont gas well within an existing 78.01-acre non-standard gas spacing unit comprising Lots 3 and 4 (W/2 SW/4 equivalent) of Section 6, Township 20 South, Range 37 East, NMPM, Eumont Gas Pool (76480). Lea County, New Mexico, which was approved by Division Administrative Order NSP-1631, dated July 23, 1991.

The subject application has been duly filed under the provisions of the "*Special Pool Rules for the Eumont Gas Pool*," as promulgated by Division Order No. R-8170-P, issued in Case No. 12563 on December 14, 2001.

By the authority granted me under the provisions of Rules 4 (B) and (D) of the special rules now governing the Eumont Gas Pool, Doyle Hartman is hereby authorized to simultaneously dedicate gas production from the Eumont Gas Pool to the above-described 78.01-acre non-standard gas spacing unit from the following two wells:

- (1) the existing Britt "A-6" Well No. 1 (API No. 30-025-05937, located at a standard gas well location, more or less, for this 78.01-acre unit 660 feet from the South and West lines (Lot 7/Unit M) of Section 6, which well was the subject of Division Administrative Order NSP-1631; and
- (2) the existing Britt "A-6" Well No. 2 (API No. 30-025-05938), located at a standard infill gas well location, more or less, 1980 feet from the South line and 660 feet from the West line (Lot 6/Unit L) of Section 6, which well is to be recompleted from the Eunice-Monument Pool to the Eumont Gas Pool.

Doyle Hartman is hereby authorized to simultaneously dedicate Eumont gas production from both the above-described Britt "A-6" Wells No. 1 and 2. Further, all provisions applicable to the subject 78.01-acre non-standard gas spacing unit in Division Administrative Order NSP-1631, not in conflict with this order, shall remain in full force and affect until further notice.

Jurisdiction of this matter shall be further retained for the entry of any such subsequent orders, as the Division may deem necessary.
