Pursuant to Division Rule 19.15.15.13, Apache Corporation ("Apache") respectfully requests administrative approval of an unorthodox oil well location for its proposed D State No. 62. This well will be drilled as a development oil well in the Artesia Glorieta-Yeso Pool (96830).

The proposed D State No. 62 will be dedicated to an existing standard 40-acre oil spacing and proration unit in the Artesia Glorieta-Yeso Pool comprising the NE/4 NW/4 of Section 36. This unit is currently dedicated to the existing Apache D State No. 25 (API No. 30-015-35869) located 330 feet from the North line and 2210 feet from the West line, and the Apache Dad State No. 43 (API No. 30-015-36278) located 1040 feet from the North line and 1550 feet from the West line.

The Artesia Glorieta-Yeso Pool is currently governed by Division Rule 19.19.15.9 which requires standard 40-acre oil spacing and proration units with wells to be located no closer than 330 feet to the outer boundary of the spacing unit.

The attached vicinity map shows that the proposed unorthodox well location is necessary in order to avoid an existing fence.

The affected offset acreage includes the SW/4 SW/4 of Section 25 and the NW/4 NW/4 of Section 36, all in Township 17 South, Range 28 East. Both of these affected tracts are existing 40-acre spacing units in the Artesia Glorieta-Yeso Pool, and both are operated by Apache. Please note however, that the working interest ownership between the NE/4 NW/4 of Section 36 and the affected offset tracts is not common.

Consequently, Apache is providing notice of this application to all working interest owners in the affected offset tracts. These working interest owners include COG Operating LLC, Khody Land & Minerals Company, Chase Oil Corporation, and Yates Petroleum Corporation.




