Reference is made to your application received on July 24, 2013.

You have requested to drill this horizontal well at an unorthodox oil well location described above in the referenced pool or formation. This location is governed by the Special Rules and Regulations for the Bell Lake Bone Spring Pool, which provides for 160-acre units, with wells located at least 660 feet from a unit outer boundary, and Rule 15.16.14.B(2) [19.15.16.14.B(2) NMAC] concerning directional wells in designated project areas. The proposed project area is a standard project area comprising two adjacent 160-acre units. This location is unorthodox because portions of the proposed completed interval are less than 660 feet from an outer boundary of the project area.
