Encana Oil & Gas (USA) Inc. (OGRID No. 282327) seeks administrative approval of an unorthodox well location for its Escrito E13-2407 01H well located in the N/2 of Section 14, Township 24 North, Range 7 West. This area is subject to the General Rules And Regulations For The Associated Oil And Gas Pools Of Northwest New Mexico And Southeast New Mexico ("General Associated Pool Rules") as well as Special Rules And Regulations For The Devils Fork Gallup Associated Pool ("Special Rules") adopted by the Commission under Order R-5353. Since Rule 2 of the Special Rules provides for 80-acre oil spacing units, Rule 2(b) of the General Associated Pool Rules requires any oil well to be located no closer than 790 feet to any quarter section line. Encana seeks an exception to this setback requirement for its Escrito E13-2407 01H horizontal well.

Enclosed as **Exhibit A** is an Amended C-102 reflecting the location of the Escrito E13-2407 01H horizontal well. It reflects that the completed interval encroaches on the quarter section lines to the South, Southeast, Southwest, East and West of the N/2 of Section 14, but remains at least 330 feet from these quarter section lines. Encana believes that this location is necessary to efficiently develop the Devils Fork Gallup oil reserves underlying this Section.

Rule 2(c) of the General Associated Pool Rules allows the "Secretary-Director of the Commission" to grant an exception to the well location requirements so long as no "offset operators" object to the application.

Enclosed as **Exhibit B** is a land plat showing the operators of existing Basin Mancos / Basin Dakota wells, leases, and all working interest in these leases for the spacing units to the South, Southeast, Southwest, East and West of the N/2 of Section 14.




