FOURTH AMENDMENT TO INACTIVE WELL AGREED COMPLIANCE ORDER

Pursuant to Ordering Paragraph 1.E of Inactive Well Agreed Compliance Order 235, the Director of the Oil Conservation Division (OCD), by and through her Compliance and Enforcement Manager, hereby amends Order 235 as follows:

FINDINGS

- 1. Yates Petroleum Corporation ("Yates") has submitted a timely and complete report to the OCD's Compliance and Enforcement Manager, and has recompleted or plugged 73 wells and is in the process of completing the wells identified on Exhibit A of Inactive Wells Agreed Compliance Order 235 Amendment D (ACOI 235-D).
- 2. ACOI 235 provides that if Yates performed recompletion work or plugging operations on at least 7 of the wells by September 1, 2013, verified by the Compliance and Enforcement Manager's review of Yates's report, the OCD shall issue a fourth amendment to ACOI 235.
- 3. Yates filed a timely and complete report, verified by OCD that the following wells have either been re-completed or plugged:

2. The OCD shall remove the wells identified on Exhibit A of ACOI 235 until September 1, 2014.

3. The terms of ACOI 235 as amended by ACOI 235-D otherwise remain in effect and are extended through September 1, 2014.
