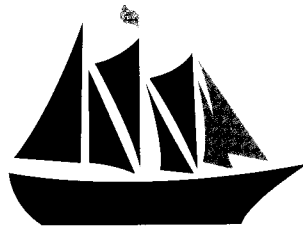
Dear Ms. Bailey:

Endurance Resources, LLC. hereby seeks administrative approval for an unorthodox well location for its Telecaster 30 Federal #4H well located in Section 30, Township 23 South, Range 34 East, N.M.P.M., Lea County, New Mexico. The proposed well is to be drilled horizontally at a surface location of 330 feet from the North line & 660 feet from the East line and a bottom hole location of 330 feet from the South line & 660 feet from the East line. A 320 acre project area has been dedicated to this horizontal well comprised of the E/2 of Section 30.

Exhibit A is a land plat for Section 30 and surrounding sections that shows the proposed non-standard location of the Telecaster 30 Federal #4H well in relation to adjoining units and existing wells. This location is unorthodox because the formation under this acreage is governed by the Bell Lake Bone Spring Pool (Pool 5130) which provides for wells to be located no closer than 660 feet to the outer boundary of the spacing unit. The location of this well will be unorthodox because the entire completed interval will be closer than 660 feet to the boundary of the project area for engineering reasons, and is, therefore, unorthodox under the Division rules.

Exhibit B is the well location and acreage dedication plat (Form C-102), which shows that the proposed Telecaster Federal 30 #4H well encroaches on the spacing and proration unit to the North, Northeast, South and Southeast.

Exhibit C is the list of affected parties that the non-standard location encroaches. The proposed well encroaches upon the spacing and proration unit to the North which affects Section 19 as well as upon the spacing and proration unit to the Northeast which affects Section 20.
