Reference is made to your application received on September 9, 2013.

You have requested to drill this well at an unorthodox oil well location described above in the referenced pool or formation. This location is governed by the special pool rules for the Counselors; Gallup-Dakota Pool and the General Rules for Associated Pools, as promulgated by Order No. R-5353, which provide for 160-acre oil units in this pool with wells located at least 790 feet from a unit outer boundary and at least 1320 feet from an existing well. This location is less than 790 feet from a unit outer boundary and is also less than 1320 feet from another well capable of producing from this pool.

Your application has been duly filed under the provisions of Division Rules 15.13 [19.15.15.13 NMAC] and 4.12.A(2) [19.15.4.12.A(2) NMAC].

It is our understanding that you are seeking this location in order to comply with United States Bureau of Land Management surface siting requirements.

It is also understood that you have given due notice of this application to all operators or owners who are "affected persons," as defined in Rule 4.12.A(2), in all adjoining units towards which the proposed location encroaches.

Pursuant to the authority conferred by Division Rule 15.13.B, the above-described unorthodox location is hereby approved.

This approval is subject to your being in compliance with all other applicable Division rules, including, but not limited to Division Rule 5.9 [19.15.15.9 NMAC].

Jurisdiction of this case is retained for the entry of such further orders as the Division may deem necessary.
