

Dear Mr. Martin:

Reliant Exploration & Production, LLC ("Reliant") (OGRID No. 251905) is seeking administrative approval under Division Rule 19.15.15.13 NMAC for an unorthodox well location for its 16-2-N Well, API 30-021-20565, located in Section 16, Township 19 North, Range 31 East, N.M.P.M., Harding County, New Mexico. According to Division Rule 19.15.15.10 NMCA, a 160-acre spacing unit area has been dedicated to this well, comprised of the SW/4 of Section 16. An APD for the well was approved by the Division on March 23, 2013, and the well was drilled pursuant to the APD at the surface location 450 feet from the quarter quarter East line of Section 16. The Administrative Application Checklist for this Application is enclosed together with Exhibit A, the Well Location and Acreage Dedication Plat (Form C-102), which shows the location of the 16-2-N Well. The C-102 shows that the well is located 450 feet from the quarter quarter East line of SW/4, Section 16. This location was necessary to efficiently and economically achieve the greatest recovery of the reserves underlying the Tubb formation in the S/W 4 of Section 16.

Pursuant to 19.15.15.13 NMAC, Reliant attests that it is the operator of the offset spacing and proration unit in the SE/4 of Section 14, that there is identical ownership of working interest, royalty and overriding royalty interests in the exactly the same percentages in the two spacing units and that therefore no other persons are entitled to notice of this Application under 19.15.4.12(A) (2) and 19.15.15.13(C).
