To whom it may concern:

On behalf of Logos Operating, LLC ("Logos") and pursuant to Division Rules pertaining to Wildcat Oil Wells we hereby notify you of our intent to produce the Logos 7 well on unorthodox well location for the to be located 1645' FNL and 180' FWL of Section 5, T22N, R5W NMPM in Sandoval County. The SW/4NW/4 of Section 5 will be dedicated to the well.


The wildcat rules for oil wells provide that wells shall be drilled not closer than 330' to any quarter-quarter section boundary. The location proposed for this well is consequently unorthodox by approximately 150' to the west and 5' to the north. The C-102 plat showing the proposed location for the well is attached hereto.

Logos seeks an exception from the applicable well location rules for the following reasons: The chosen location was most practical based operational efficiencies and on BLM onsites which identified multiple cultural and environmental issues.

Please note that Logos Operating, LLC/ Logos Resources, LLC is the only operator and owner in the ALL of section 5-8, T22N, R5W, NMPM and therefore no notification is required to other owners or operators. The Jicarilla Apache Nation is the only royalty owner. This permit has been approved by the Jicarilla Apache Nation.

As such, Logos requests your consideration of this application and if acceptable, the approved NSL for the Logos 7 well as quickly as possible.
