WPX Energy Production, LLC ("WPX"), pursuant to the provisions of Division Rule 19.15.15.13, hereby seeks administrative approval of an unorthodox location for the Lybrook Gallup (42289) formation in the Chaco 2206-02P #227H. This is a horizontal well with a surface location of 614' FSL and 817' FEL and an end of lateral location of 1531' FSL & 230' FWL, Section 2, T22N, R6W. See attached plat.

This location is governed by statewide Rule 15.9.A [19.15.15.9.A NMAC], which provides for 40-acre units, with wells located at least 330 feet from a unit outer boundary. Initially the Lybrook Gallup Pool was set up with Special Pool Rules under Order No. R-2267 but these rules were later abolished with Order No. R-2267-B. The new Special Rules for Horizontal Wells under Division Rule 19.15.16.15(B)(3) also apply and state no internal setbacks are required within a project area. Given these setback requirements, this location is encroaching the S2 of the S2 of Section 2, T22N R6W in that it is 190' from the unit boundary. Even though the end of lateral is at 230' FWL, the final perforation will be within the 330' setback requirement.

The spacing for the subject well is the N/2 of the S/2 of section 2 consisting of 4 consecutive 40 acres parcels. The spacing unit being encroached upon is the S/2 of the S/2 of Section 2 also consisting of 160 acres. All of Section 2 is operated by WPX and ownership is 100% WPX therefore no affected owner letters are required pursuant to NMOCD rules.
