Your application on behalf of Merrion Oil & Gas Corporation (Merion) has been duly filed under the provisions of Division Rules 19.15.15.11C. NMAC and 19.15.4.12A.(2) NMAC.


It is our understanding Merrion has proposed the simultaneous dedication of this unit to the two wells described for geologic and engineering reasons, in order to prevent waste and maximize production from this unit.

We further understand that ownership of the subject unit and of all offsetting 160-acre units in this pool is identical, so that no notice of this application to offsetting operators or owners is necessary.
