The commingled oil production from the wells detailed above shall be measured and sold at the Corbin South Federal #2 in Unit L, Section 9, T18S, R33E NMPM, Lea County, New Mexico. Gas sales meter will be located .5 miles east of the facility.

The oil and gas production from each well shall be continuously measured with allocation meters before commingling with production from other wells. The allocation meters shall be calibrated quarterly.

This installation shall be installed and operated in accordance with the applicable Division Rules. It is the responsibility of the producer to notify the transporter of this commingling authority.

The proposed lease commingling (CTB) is in the best interests of conservation and prevention of waste from the affected wells. Correlative rights will not be impaired, and will not result in reduced royalty or improper measurement of production


