Pursuant to Division Rule 19.15.15.13 (NMAC), Mewbourne Oil Company ("Mewbourne") respectfully requests administrative approval of an unorthodox well location for its proposed Layla 35 MD Fee No. 2H. This well will be drilled as a horizontal development well in the South Culebra Bluff-Wolfcamp (Gas) Pool (75750).

The Layla 35 MD Fee No. 2H will be dedicated to a standard 320-acre gas spacing and proration unit comprising the W/2 of Section 35. There are currently no other wells producing from the Wolfcamp formation within the proposed spacing unit.

The South Culebra Bluff-Wolfcamp (Gas) Pool is currently governed by Division Rule 19.15.15.10.(B) (NMAC) which requires standard 320-acre spacing and proration units with wells to be located no closer than 660 feet to the outer boundary of the quarter section in which the well is located, and no closer than 10 feet to a quarter-quarter section line or subdivision inner boundary, or in the case of a horizontal well, no closer than 660 feet to the outer boundary of the spacing unit.

The proposed unorthodox gas well location is necessary in order to maximize the recovery of oil and gas reserves from the Wolfcamp formation underlying the W/2 of Section 35.

The 160-acre tracts that are directly affected by the proposed unorthodox gas well location are the SE/4 of Section 27 and SW/4 of Section 26, both in Township 23 South, Range 28 East, and the NW/4 of Section 2 and NE/4 of Section 3, both in Township 24 South, Range 28 East (**See Attached Map**). There is currently no Wolfcamp development in any of these affected quarter sections, and consequently, there are no

established 320-acre spacing units. Since there are several possible 320-acre Wolfcamp spacing unit orientations subsequently established that comprise the four affected offset 160-acre tracts, Mewbourne is providing notice of this application to the lessees/owners in the E/2 and SW/4 of Section 27, W/2 and SE/4 of Section 26, W/2 and NE/4 of Section 2, and the E/2 and NW/4 of Section 3. These tracts, and the interest ownership within these tracts, is shown on the attached map and notice list. Please note that Mewbourne is also publishing notice of this application in the Artesia Daily News in order to provide notice to certain interest owners within Tract 3 whose address is unknown.

Attached is an approved APD (Form C-101). Also attached is a Form C-102 showing the proposed well and spacing unit and a map that shows the surface, first take point and bottomhole locations of the Layla 35 MD Fee No. 2H, the proposed spacing unit, affected offset acreage and tract identification.

In summary, approval of the application will provide Mewbourne Oil Company the opportunity to recover additional oil and gas reserves from the South Culebra Bluff-Wolfcamp (Gas) Pool underlying the W/2 of Section 35 that may otherwise not be recovered, thereby preventing waste, and will not violate correlative rights.

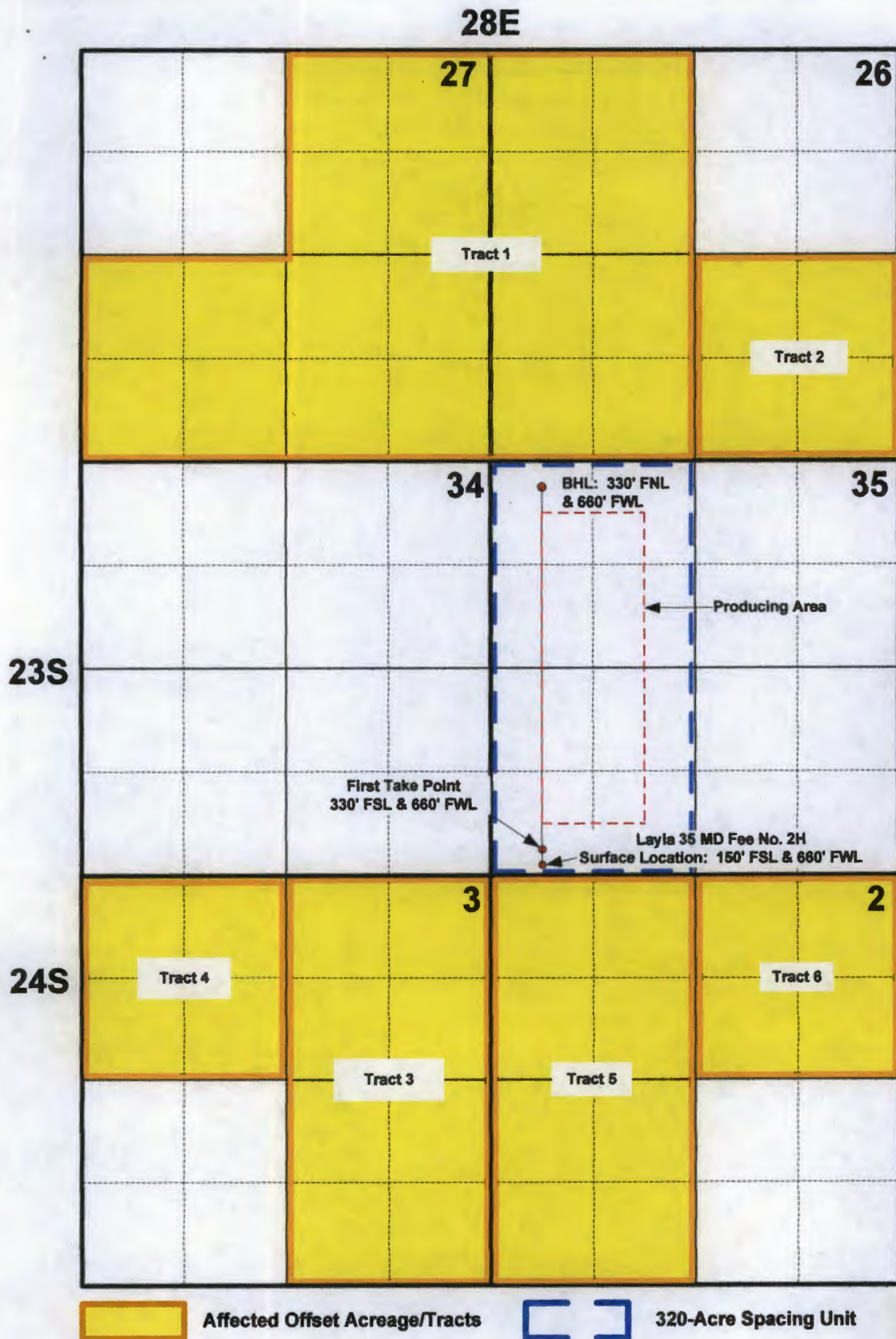
