The commingled oil and gas production from the Jackson Unit Well No. 16H and Jackson Unit Well No. 17H shall be measured and sold at the central tank battery (CTB), located in Unit B of Section 15, Township 24 South, Range 33 East, NMPM, Lea County, New Mexico.

The commingled oil and gas production from the Jackson Unit Well No. 20H and Jackson Unit Well No. 21H shall be measured and sold at the central tank battery (CTB), located in Unit O of Section 21, Township 24 South, Range 33 East, NMPM, Lea County, New Mexico.

The commingled oil and gas production from the Jackson Unit Well No. 24H and Jackson Unit Well No. 25H shall be measured and sold at the central tank battery (CTB), located in Unit O of Section 22, Township 24 South, Range 33 East, NMPM, Lea County, New Mexico.

The oil production from each well shall be continuously measured with allocation meters before commingling with production from other wells. The allocation meters shall be calibrated quarterly in accordance with Rule 19.15.12.10.C (2) NMAC.

This installation shall be installed and operated in accordance with the applicable Division Rules. It is the responsibility of the producer to notify the transporter of this commingling authority.

The operator shall notify the Hobbs District office of the Division prior to implementation of the commingling operations.

**This approval is subject to like approval from the New Mexico State Land Office before commencing commingling operations.**
