Matador filed its application on June 1, 2015. Matador is amending the perforation points for the well because a protest was filed by Mr. Charles A. Skeen, who is an affected party in Section 2, Township 22 South, Range 27 East, N.M.P.M., Eddy County, New Mexico. The Scott Walker 36-22S-27E RB #204H is a horizontal well that will now be drilled as follows:

- Surface Hole Location: 330 feet from the South line and 635 feet from the West line of Section 36;
- First Perforation Point: 660 feet from the South line and 660 feet from the West line of Section 36;
- Last Perforation Point: 660 feet from the South line and 330 feet from the East line of Section 36; and
- Bottom Hole Location: 660 feet from the South line and 240 feet from the East line of Section 36.
