NOTICE OF PUBLICATION

Notice is hereby given that pursuant to Water Quality Control Commission Regulations (20.6.2.3106 NMAC), the following discharge permit application has been submitted to the Director of the Oil Conservation Division (OCD), 1220 S. Saint Francis Drive, Santa Fe, New Mexico 87505. Telephone (505) 476-3440:

(GW-040) Mr. James R. Schmoltz of Western Refining Southwest located at 111 County Road 4990, Bloomfield, New Mexico 87413, has submitted a renewal application for the previously approved discharge plan for its Former Bloomfield Refinery, located in the NW/4 of Section 27 and the SW/4 of Section 22, Township 29 North, Range 12 West, NMPM, San Juan County, New Mexico, located approximately five miles west of Bloomfield, New Mexico.

During 2010, the Owner/Operator processed approximately 1,120,000 gallons of contaminated ground water in a ground water remediation system. Groundwater most likely to be affected by a spill, leak, or accidental discharge is at a depth of approximately 5 to 10 feet, with a total dissolved solids concentration of approximately 1,700 to 3,100 mg/l. The discharge plan addresses how contaminated ground water will be remediated and disposed of.

OCD has determined that the application is administratively complete and has prepared a draft permit. OCD will accept comments and statements of interest regarding this application and will create a facility-specific mailing list for persons who wish to receive future notices. Persons interested in obtaining further information, submitting comments or requesting to be on a facility-specific mailing list for future notices may contact the Environmental Bureau Chief of the Oil Conservation Division at the address given above. The administrative completeness determination and draft permit may be viewed at the above address between 8:00 a.m. and 4:00 p.m., Monday through Friday, or may also be viewed at OCD's web site

<http://www.emnrd.state.nm.us/oed/>. Persons interested in obtaining a copy of the application and draft permit may contact the OCD at the address given above. Prior to ruling on any proposed discharge permit or major modification, the Director shall allow a period of at least thirty (30) days after the date of publication of this notice, during which interested persons may submit comments or request that OCD hold a public hearing. Requests for a public hearing shall set forth the reasons why a hearing should be held. A hearing will be held if the Director determines that there is significant public interest.

If no public hearing is held, the Director will approve or disapprove the proposed permit based on information available, including all comments received. If a public hearing is held, the director will approve or disapprove the

proposed permit based on information in the permit application and information submitted at the hearing.
