Apache would like to amend Administrative Surface Commingling Order PC-1213 including the currently producing pools and adding Blinebry Oil & Gas (Oil – 6660) & Tubb Oil & Gas (Oil – 60240). Apache refers to this battery as Turner 29 due to the fact that 4 wells on the Turner lease reside in Section 29, while all other wells on the lease reside in Section 22. Wells 5 & 6 produce from GB/SA formations, while wells 7 & 10 produce from B/T, and commingling allows one battery for each section.

Enclosed please find forms C-102 and well test information for all wells at this battery. All four wells are marginal producers and production will be allocated monthly by well tests. Per attached land letter, interest ownership between pools is identical and common throughout.

In the event Apache were to add wells and leases to this commingling order, we request to only notify interest owners in the wells and leases to be added, per Division Rule 19.15.12.10C(4)(g) NMAC.

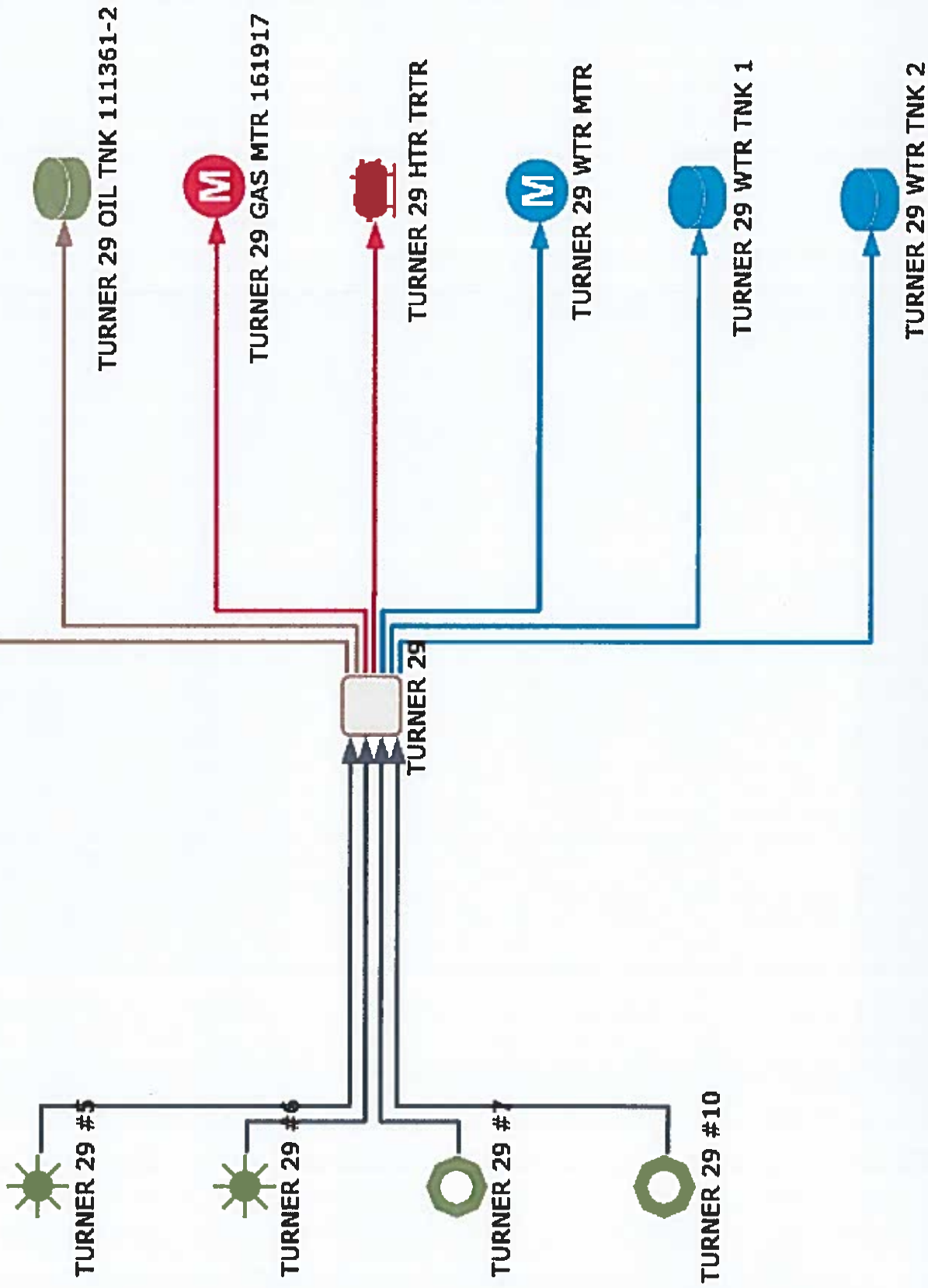
