Devon Energy Production, LP (“Devon”) (OGRID No. 6137) seeks to amend the administrative approval granted in NSL-7902, authorizing an unorthodox well location for its **Mr Potato Head 11-14 Fed Com 624H Well** (API No. Pending) to be completed within the Purple Sage Wolfcamp Pool (98220) underlying the E/2 of Sections 11 and 14, Township 24 South, Range 29 East, N.M.P.M., Eddy County, New Mexico.

NSL-7902 authorized Devon to drill its well at the following location:

Devon has changed its drilling plans for the **Mr Potato Head 11-14 Fed Com 624H Well** and now intends to drill this well from a surface location 300 feet from the north line and 606 feet from the east line (Unit A) of Section 11 to a bottom hole location 20 feet from the south line and 1,254 feet from the east line (Unit P) of Section 14. The first take point will be located 120 feet from the north line and 1,254 feet from the east line (Unit A) of Section 11 and the last take point will be 120 feet from the south line and 1,254 feet from the east line (Unit P) of Section 14. A revised Form C-102 for this well is attached as **Exhibit 1**.

Accordingly, Devon requests the Division amend NSL-7902 to reflect the above-described changes to the surface and bottom hole locations and first and last take points of the **Mr Potato**

**Head 11-14 Fed Com 624H Well.** Each of the parties listed on Exhibit C to the original application have been provided notice of this application by certified mail, including the Bureau of Land Management.

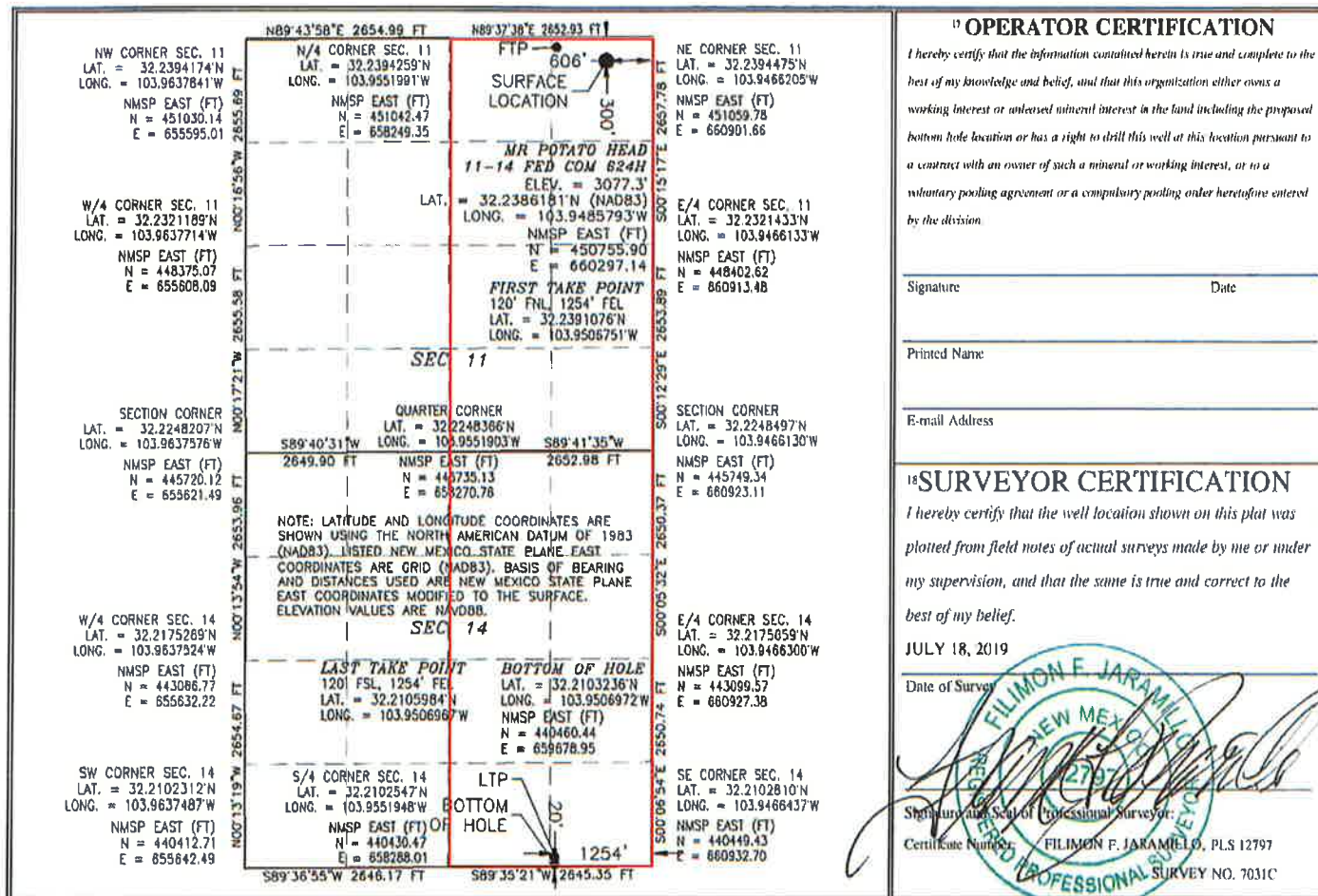

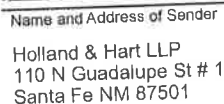
