Updated Table 2 that identifies missing data:

- Mineral owners for areas of unleased private land through title search. (T23S.34S.Sec 23.UL I and T 23S.34E.Sec12.UL M)
- Missing lessee name NMNM 132073 (BLM Serial Register) this lessee was already notified in original mailing

Supplemental Mailing list and Proof of mailing for identified mineral owners

All operators were previously identified on Table 1 and previously notified, therefore, all affected persons within 1 mile of this well site have been notified.

I have included below, the original email notifying us of the suspension with response to the concerns in red text.

I also included text from section V C108 that discussed action we were taking to obtain data.

your application is suspended.

I-236-23S-34E need justification for Unknown lessor. We advised we were doing a title search – now have that data and have done notification mailings

Why wasn't the lessee notified? The area was unleased.

E/2 and E/2 SW/4 Section 15 not notified. Not accurate – we did notify Devon Energy and Mewborne – clear on original Table 2 and proof of notification.

NE/4 (Endeavor and Siana were notified- clear on original Table 2 and proof of notification) and N/2 SE/4 of Section 22 not notified. This data was missing from our data sources (NMNM 132073) and we have since identified that Centennial is the lessee (BLM Serial Register) – had already notified them with original mailing as they were included with other leases

Clarify that any portion of SW/4 SW/4 of Section 12 is within 1-mile AOR. We are likely only a few feet into this area at 1 mile, however, we did include and we also had to do a title search for mineral owners in that area. We now have that data and notification mailings have been completed.

We explained the reason for missing information in section V of the C108 with following text:

"Note that T23S R34E Section23 Unit Letter I, south of the proposed SWD, and all Section 12, north of the proposed SWD are shown as unleased in Plate 2a. We contacted

the surface owner, Limestone Basin Ranch Prop LLC, and found that there is no knowledge of a private oil and gas mineral interest holder. There is no past or present oil

and gas production from Unit Letter I of Section 23 and no current production in Section 12. We are conducting a title search for these parcels to determine mineral ownership and will notify the majority interest owner if said owner has not already been

notified in the mailing to affected parties."
