All: Novo Oil & Gas Northern Delaware, LLC ("Novo") objects to the following six administrative applications for unorthodox gas well locations (Purple Sage-Wolfcamp Gas Pool) filed by Marathon Oil Permian LLC:

Valkyrie 12 WA Fed. Com. Well No. 7H Valkyrie 12 WXY Fed. Com. Well No. 9H Valkyrie 12 WA Fed. Com. Well No. 11H Valkyrie 12 WD Fed. Com. Well No. 8H Valkyrie 12 WD Fed. Com. Well No. 10H Valkyrie 12 WD Fed. Com. Well No. 12H

All of the proposed wells are located in the S/2 of Section 12-23S-28E and the S/2 of Sec. 7-23S-29E, Eddy County.

Novo proposes to drill wells to the east of Marathon's wells, in Sections 8 and 9-23S-29E, which have standard setbacks. Thus, Novo's correlative rights are adversely affected.
