DJR Operating, LLC ("DJR Operating") (OGRID No. 371838) seeks administrative approval of an unorthodox well location for its **Betonnie Tsosie Wash Unit #720H well** (API No. 30-045-35669) to be completed within the Betonnie Tsosie Wash Unit; Mancos (Oil) Pool (Pool Code 98175) underlying the NE/4 NE/4 of Section 3, Township 22 North, Range 8 West, and the S/2 SE/4 of Section 28, the NE/4 NE/4 of Section 33, and the W/2 NW/4, the SE/4 NW/4, the NW/4 SW/4, the W/2 SE/4, and the SE/4 SE/4 of Section 34, Township 23 South, Range 8 West, N.M.P.M., San Juan County, New Mexico. The horizontal well has been drilled as follows:

- Surface hole location: 1,308' FNL, and 17' FEL (Unit A) of Section 3
- Bottom hole location: 696' FSL, and 1,412' FEL (Unit O) of Section 28
- First take point: 583' FNL, and 165' FEL (Lot 1) of Section 3
- Last take point: 648' FSL, and 1,363' FEL (Unit O) of Section 28

The **Betonnie Tsosie Wash Unit #720H well** is a unit well within the Betonnie Wash Exploratory Unit. **Exhibit A** is a map of the Betonnie Wash Exploratory Unit. Division rules require the completed interval for this unit well to remain at least 330 feet from the outer boundary of the Betonnie Wash Unit. As shown on the as-drilled Form C-102, attached as **Exhibit B**, the initial portion of the completed interval for this well at the first take point is only 248 feet from the outer boundary of Section 2.

Exhibit B is also a land plat for Sections 2 and 3, Township 22 North, Range 8 West, and Sections 28, 33, 34, Township 23 South, Range 8 West, that shows the proposed **Betonnie Tsosie**

Wash Unit #720H well in relation to the adjoining spacing unit to the east in the W/2 W/2 of Section 2, which is also operated by DJR Operating and dedicated to the Lybrook M35 2308 O1H well.

The Bureau of Land Management and DJR Operating are only affected parties in this application. DJR Operating owns 100% of the working interest in the affected tract in the NW/4 NW/4 of Section 2. Exhibit C includes the waiver received from the BLM, as reflected below, and thus, DJR Operating respectfully requests the Division's immediate approval:



DJR Operating, LLC ("DJR") intends to submit an application to the New Mexico Oil Conservation Division for approval of a non-standard location for the recently drilled Betonnie Tsosie Wash Unit 720H well to be completed in the Mancos Oil Pool (Pool Code #98175) underlying the following lands:

SHL: T22N-R8W, Section 3: Lot 1 (NENE) (A), San Juan County, NM BHL: T23N-R8W Section 28: SWSE (O), San Juan County, NM

This is a unit well within the Betonnie Tsosie Wash Unit (NMNM 135219X).

Division rules require the completed interval for this unit well to remain at least 330 feet from the outer boundary of the Betonnie Tsosie Wash Unit. As shown on the attached As Drilled plat, the initial portion of the completed interval for this well at the first take point is 248 feet from the outer boundary of the Unit at the NWNW of Section 2 (T22N-R8W). This well therefore is unorthodox by 82 feet. This encroachment impacts Federal Lease NMNM 04989A which covers the NWNW of Section 2. DJR owns 100% of the working interest in this federal lease and operates the Lybrook M35-2308-01H well dedicated to the W2W2 of Section 2.

DJR inadvertently utilized an incorrect completion procedure for the well which did not reflect the correct bottomhole coordinates for the first take point, causing the encroachment.

Division Rules provide that an application for a non-standard location may be approved more quickly if the applicant obtains waivers from affected parties. DJR respectfully requests BLM's waiver of objection to this non-standard location in order to expedite the Division's approval process by signing the bottom of this letter.
