Sorry for the delay in getting back to you, but finally got the information requested:

1. Please confirm that each of the follow tracts of land are either single leases or pooled areas.

E/2	Sec 8-T23S-R27E
S/2	Sec 9-T23S-R27E

Cypress 1 in the E2 of 8-23S-27E: was not compulsory pooled, it was a voluntary unit. Our predecessor owned 100% of WI, drilled the well and just filed a pooling declaration for the leases. It is all Fee there is not State or Fed CA.

Cypress 5 in the S2 of 9-23S-27E: similar story, was not compulsory pooled, is a voluntary unit. At the time of drilling there were two WI owners, both executed JOA and voluntary pooling declaration to form the unit. It is all Fee there is not State or Fed CA.

Both are in pooled areas and all necessary steps to pool WI and Revenue Owners were appropriately applied.
