Ms. Sandoval:

XTO Permian Operating, LLC (XTO) respectfully requests an extension to the subject Administrative Order for a produced water disposal well. XTO is requesting a 30-day extension to this order.

Administrative Order SWD-1746 was approved September 25, 2019 giving XTO one year to begin injection operations. The well has been drilled and completed. An initial MIT was performed on July 02, 2020 and passed. Due to some miscommunication, the original recorder chart did not get submitted to the NMOCD Artesia office. The omission was discovered last week prior to beginning injection. This permit extension will allow XTO to perform another MIT and begin disposal operations prior to October 25, 2020.

The well was not permitted as a "high volume" injection well, and only required a one half (1/2) mile Area of Review. New wells have been permitted to drill inside this radius but none of the wells is proposed to penetrate the disposal formation therefor, there is no change in the AOR.


