Oil Production:

The oil production from all wells will be measured separately on-lease by allocation meter prior to being commingled at the heater treaters at the Central Tank Battery located in lease in Ut. P, Sec 21-T25S-R28E. In addition to the on-lease measurement, the oil production from these wells may also be transported by truck to either the Red Hills Offload Station, located in Unit O, Section 4-T26S-R32E, or the Jal Offload Station, located in Unit D, Section 4-T26S-R37E, Lea County in the event the CTB on lease is over capacity or in the case of battery or pipeline repairs. In this case the oil will remain segregated and will be measured by lact meter when offloading at said stations.

Gas Production:

Gas produced from all wells will be measured on-lease by allocation meter prior to being commingled and entering a flow line to the gas custody transfer meter. The custody transfer meter is located in Ut. P, Sec. 21-T25S-R28E which is at the Central Tank Battery location.


