Spur Energy Partners LLC respectfully requests administrative approval of a non-standard location on the Rose South 10H, API Number 30-015-Pending, Property Code Pending. The 10H well is proposed to be completed in the Penasco Draw; SA-Yeso (Assoc) pool, Pool Code 50270. The proposed wellbore is to be completed within 330’ feet of the S/2 of the N/2 of Section 12. The proposed interval is projected as follows:

Surface Hole – 2260’ FSL 700’ FWL Lot 3 Sec 7 T19S R26E
First Take Point – 2430’ FSL 100’ FEL Unit I Sec 12 T19S R25E
Last Take Point – 2430’ FSL 100’ FWL Unit L Sec 12 T19S R25E
Bottom Hole – 2430’ FSL 50’ FWL Unit L Sec 12 T19S R25E

The adjoining units which the unorthodox location encroaches are located in T19S R25E, Section 12, Units E, F, G and H.

Approval of the unorthodox completed interval will allow for efficient spacing of horizontal wells and thereby prevent waste.

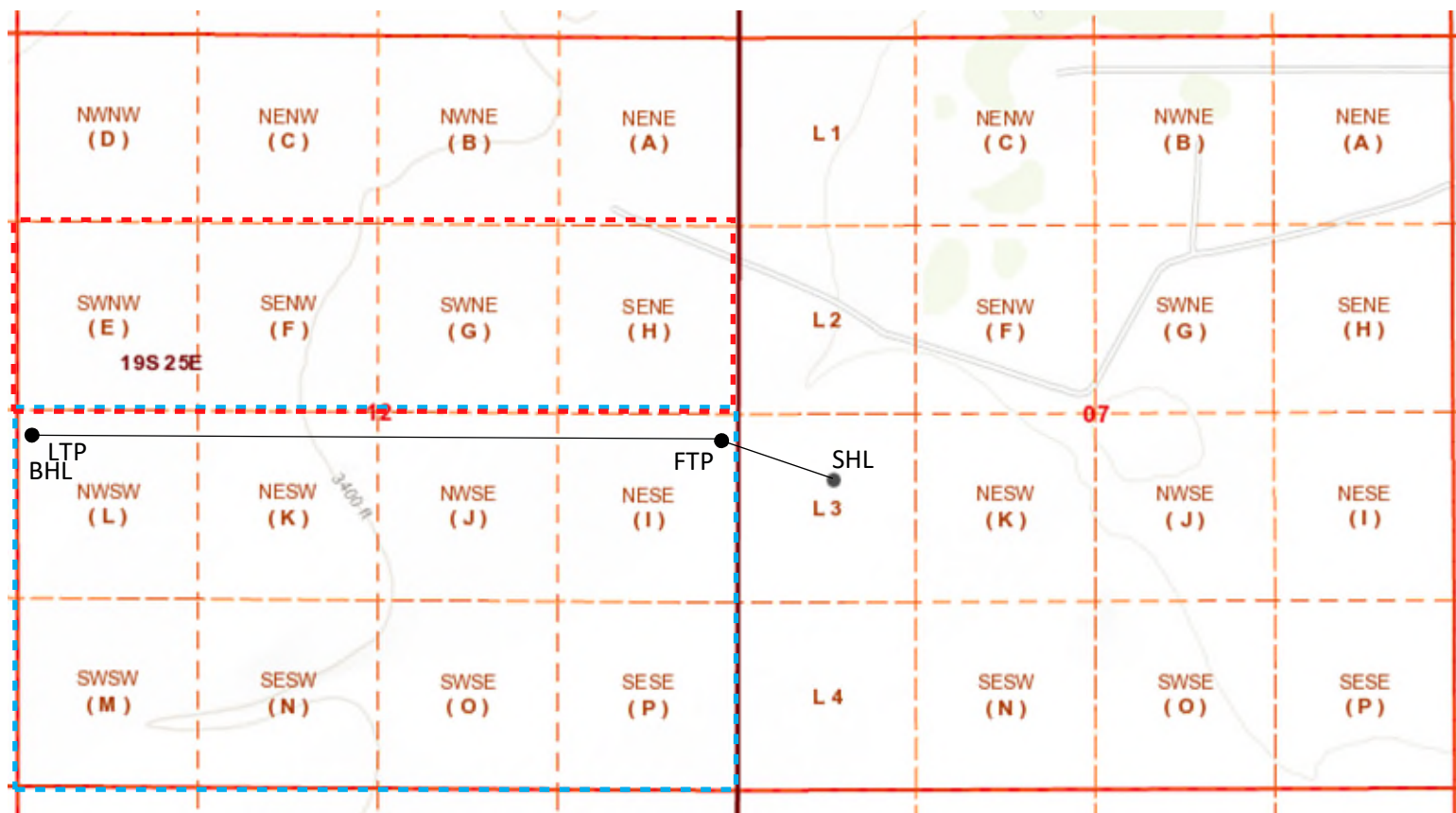
