Spur Energy Partners LLC respectfully requests administrative approval of a non-standard location on the Shorty 2 State Com 10H, API Number 30-015-Pending, Property Code Pending. The 10H well is proposed to be completed in the Loco Hills; Glorieta-Yeso pool, Pool Code 96718. The proposed wellbore is to be completed within 330' feet of the N/2 of the N/2 of Section 2. The proposed interval is projected as follows:

Surface Hole – 1978' FNL 205' FWL Unit E Sec 2 T17S R30E
First Take Point – 1425' FNL 100' FWL Unit E Sec 2 T17S R30E
Last Take Point – 1425' FNL 100' FEL Unit H Sec 2 T17S R30E
Bottom Hole – 1425' FNL 50' FEL Unit H Sec 2 T17S R30E

The adjoining units which the unorthodox location encroaches are located in T17S R30E, Section 2, Lots 1, 2, 3 and 4.

Approval of the unorthodox completed interval will allow for efficient spacing of horizontal wells and thereby prevent waste.



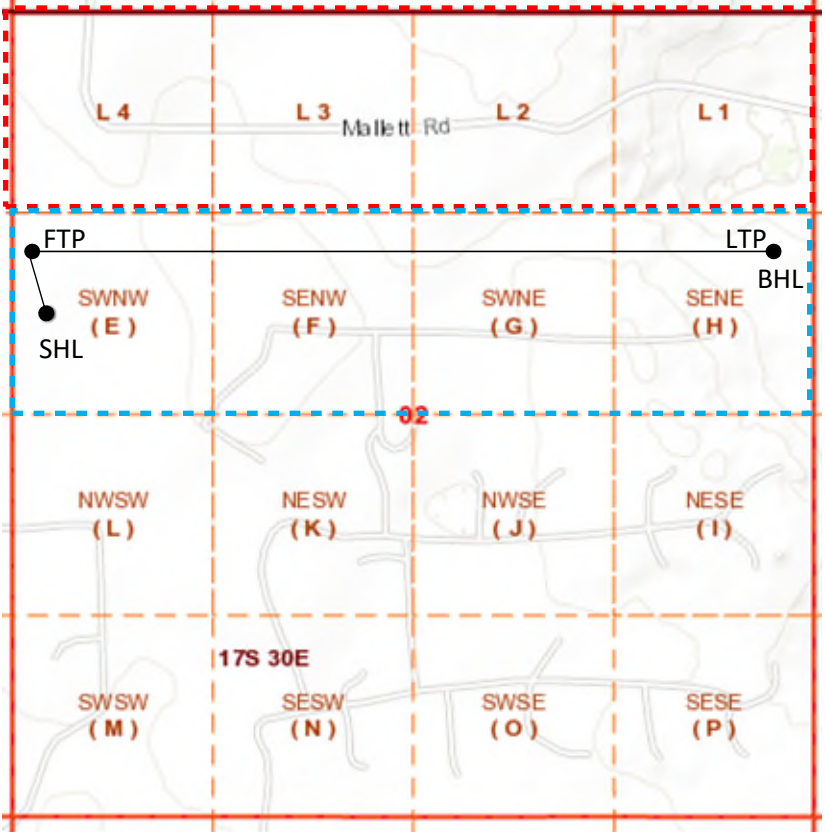
