Hi Dean,

Hope all's good with you and yours!

Hey, a few years ago we got the DHY B State SWD permitted for Ray Westall. We requested an extension while waiting for SLO to process/ approve the SWD easement on state land. Mike McMillan left OCD and they lost the request – I provided them a copy. Just this week, SLO finally approved the SWD easement. OCD wanted me to review the AOR again and Apache and Mewbourne both completed horizontal wells within the ½ mile. RWO would be injecting into the Cisco/ Canyon below the BS completions. **As mentioned, RWO had the permit but it took 2-1/2 years for the various regulatory processes.**

Anyway, my question is, do I need to send the information to your attention or someone in NM? The well is 30-015-21971 in 'L'-11-19S-28E. Apache's wells in the AOR are the Palmillo 10 State wells – several of them along the east line of section 10 with laterals extending away to the west.

Mewbourne has already given me their consent to proceed with a new/ updated extension request for the subject permit – hoping Apache sees it similar but in any event, please let me know if you have any questions.
