Reference is made to your application received on August 17<sup>th</sup>, 2021.

This vertical well was drilled at an unorthodox oil well location described above in the referenced pool or formation. This location is governed by statewide rules, which provides for 80-acre units, with wells to be located at least 460 from the QTR/QTR line.

This well's completed interval is as close as 660 feet to the northern boundary. Encroachment will impact the following tracts.

Section 36, encroachment to the N/2 NW/4

The Division understands you have given notice of this application to all operators or owners who are "affected persons," as defined in Paragraph (8) Subsection A of 19.15.2.7 NMAC, in all adjoining units towards which the proposed location encroaches. You are 100% working interest within the affected tract, therefore notice is not required.

---

Division understands that you are recompleting an existing vertical well within this formation, resulting in an unorthodox location. The division understands the intention to prevent waste within the Abo formation underlying the S/2 NW/4 of Section 36.

Your application has been filed under Subsection 6 of Paragraph of Section (C) of 19.15.16.15 NMAC, 19.15.15.13 NMAC and Paragraph (2) of Subsection A of 19.15.4.12 NMAC.

Per Subsection B of 19.15.15.13 NMAC, **Division approves this unorthodox location.**

The above approvals are subject to your following all other applicable Division rules.

Jurisdiction of this case is retained for the entry of further orders as Division deems necessary.
