You have requested to complete this horizontal well as a gas well described above in the referenced pool or formation. Division understands you are seeking this unorthodox location to allow for efficient spacing of wells and thereby preventing waste within the Wolfcamp formation underlying the W/2 of section 12, E/2 of section 11, W/2 of section 13 and the E/2 of section 14.

Your application has been filed under 19.15.16.15(C)(6) NMAC, 19.15.15.13 NMAC and 19.15.4.12 (A)(2) NMAC.

Per Subsection B of 19.15.15.13 NMAC, Division approves this unorthodox location.
