Here are the requested items.

- 1). Confirmation of BLM submittal of oil commingle application
  - Attached is the AFMSS submittal 2633045
- 2). Heads CC Federal Com #22H pool update to ID #96473
  - Attached is the amended C-102 to reflect Pool 96473, and the AFMSS submittal confirmation; awaiting BLM approval
- 3). The Heads CAs are in the process of being prepared for submittal to BLM.
  - Because they have not been submitted and approved yet, all WIO/RIO/ORR owners were notified of the commingle application.
  - Tracking numbers and the newspaper publication are included in the original application. Also attached are copies of the CAs.

We really appreciate you working with us on this commingle approval with such a short fuse! It looks like the BLM was notified of the gas commingle for PLC-750-B, but I am not seeing the BLM notification for the oil commingle in PLC-783. It's possible I may have it in my email, but I am not seeing it from an initial search. Please confirm that the BLM has been notified of this application.

Please provide a state update on correcting the pool for the Heads CC 9 4 Federal Com #22H (30-015-47335) from pool ID #96238 to pool ID #96473.

I am not seeing submittals for the CAs for these wells within the BLM system that is publicly available. As such, please provide the packets for the CAs covering these wells.
