Please also note the following:

- The Communitization Agreement has not been submitted to BLM yet. Because of this, all owners have been notified of the commingle application. If the CA is approved, all wells will have identical ownership. The map in the commingle submittal shows the boundary of the planned CA and states that approval is pending.
- BLM commingle application has not been submitted yet. We plan to do so within the next two weeks and will send the AFMSS submittal confirmation to you.
- Pool for Heads CC 9 4 Fed Com 22H (30-015-47335) is being updated to reflect Pierce Crossing; Bone Spring, East (96473) rather than Corral Draw; Bone Spring (96238). We have detailed this in the write-up and also included both C-102 forms. All owners received this detail in the commingle application that has been mailed out.
