Dear Mr. Jackson

Pursuant to the conditions of NMOCD-ACO-2020-009 ("Order"), EOG Resources, Inc. ("EOG") is required to submit a report no later than twelve months, twenty-four months, and thirty-six months after the date of issuance of the Order. The report states whether the well has been restored to production, placed on approved temporary abandonment status, or plugged. Additionally, EOG is required to conduct a Bradenhead test on each well no later than twelve months, twenty-four months, or thirty-six months after the date of issuance of this Order and is also required to submit a compliance report for each test not later than thirty days after the date of that test.

Following consultation with the New Mexico Oil Conservation Division ("OCD"), EOG is submitting this report, along with Bradenhead tests and testing schedule, within an agreed extended timeframe.

Since the approval of the Order, EOG has made diligent progress in addressing all wells covered under the terms of the Order. We respectfully request that you consider this document and attachments to constitute EOG's twenty-four month report for the Order. At the time the Order was approved, there were 137 wells covered under the terms of the Order. As of today's date, EOG has removed 105 wells from the Order by either returning them to production or plugging and abandoning the. A balance of 32 wells remain covered by the terms of the Order going forward. The attached Exhibit illustrates the current status of each well, the results of the Bradenhead tests, and EOG's intended plan of action for each well still covered by the Order.
