Advance Energy Partners Hat Mesa, LLC (OGRID No. 372417) request administrative approval for a nonstandard location (NSL) for the proposed Anderson Federal Com 505H (30-025-49428), located in a 240-acre horizontal spacing unit in the W2SW of Section 26 and W2EW of Section 35, Township 21 South, Range 32 East, Lea County, New Mexico.

The as-drilled surface and bottom hole locations and first and last take points are as follows:

- The surface location is located 180 feet from the north line and 776 feet from the west line (Lot 4) of Section 2, T22S-R32E.
- The bottom hole location is located 2,554 feet from the south line and 1,231 feet from the west line (Unit L) of Section 26, T21S-R32E.
- The first take point is located 102 feet from the south line and 1,158 feet from the west line (Unit M) of Section 35, T21S-R32E.
- The last take point is located 2,540 feet from the south line and 1,231 feet from the west line (Unit L) of Section 26, T21S-R32E.

The Anderson Federal Com 505H (30-025-49428) is an oil well located in Red Tank; Bone Spring pool [51683]. The Anderson Federal Com 505H is an infill well in the horizontal spacing unit for the Anderson Federal Com 501H (API: 30-025-48891).

Since this acreage is governed by the Division's statewide rules, the completed interval for this well will be unorthodox because the first take point and last take point are closer than the standard offsets to the eastern boundary of the spacing unit and encroaches on the E2SW of Section 26 and E2W2 of Section 35, Township 21 South, Range 32 East, Lea County, New Mexico. Approval of the NSL will allow Advance to use its preferred well spacing for horizontal wells in this area and thereby maximize recovery and prevent waste.

**Exhibit A** is a Form C-102 showing the completed interval of the Anderson Federal Com 505H well which encroaches on the spacing unit/tracts to the east in the E2SW of Section 26 and E2W2 of Section 35.


**Exhibit B** is a plat for Sections 26 and 35 that shows the Anderson Federal Com 505H well in relation to the adjoining spacing unit/tracts to the east. As shown on the plat, the affected spacing unit to the east as to the SESW of Section 26 and E2W2 of Section 35 is operated by Advance Energy Partners Hat Mesa, LLC. The NESW of Section 26 is unleased lands owned by the BLM. The BLM has not made this tract available for leasing due to the lesser prairie chicken. A notification letter has been sent to the BLM. Accordingly, the only “affected persons”<sup>1</sup> are the applicant, Advance Energy Partners Hat Mesa, LLC and the BLM.

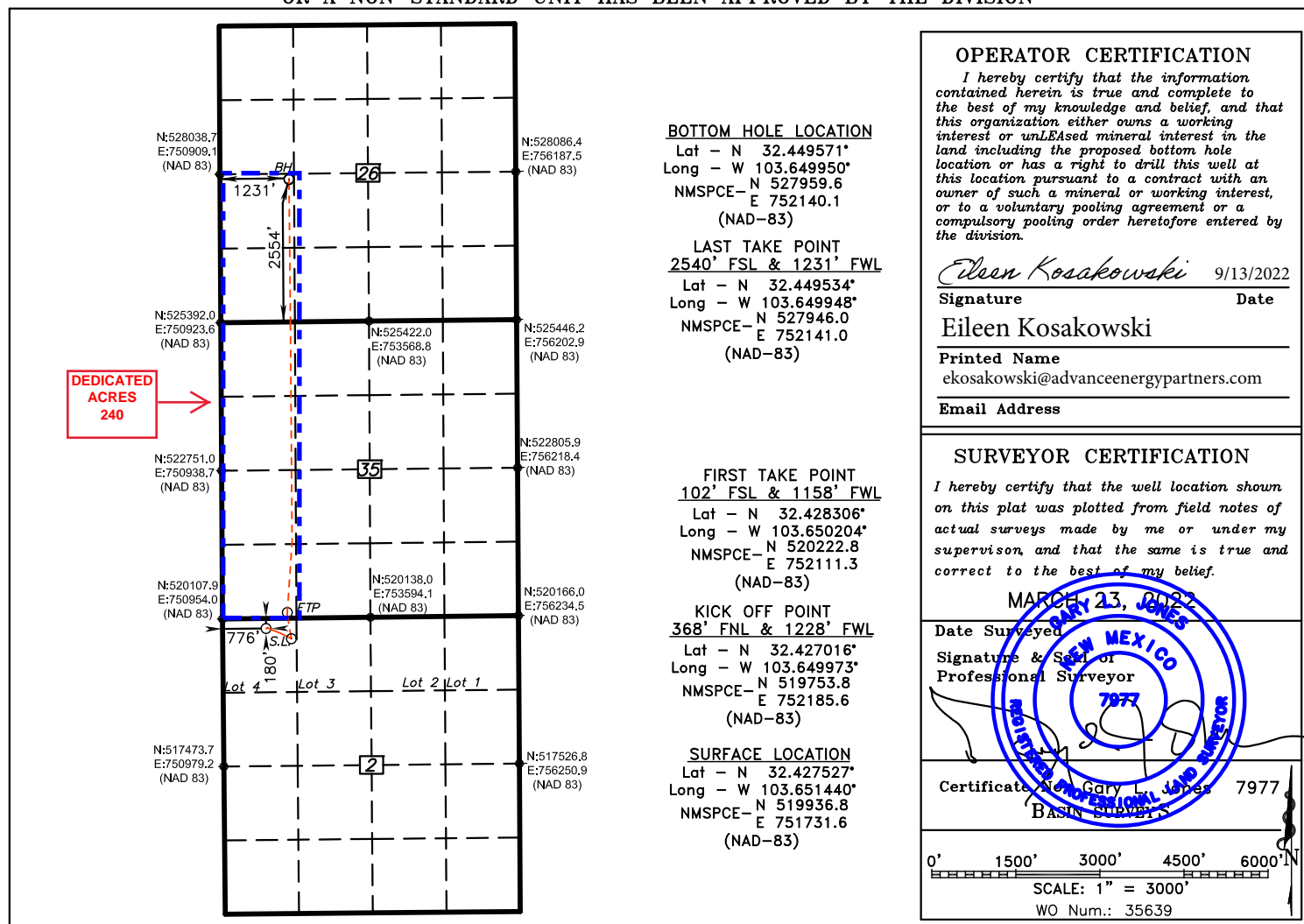

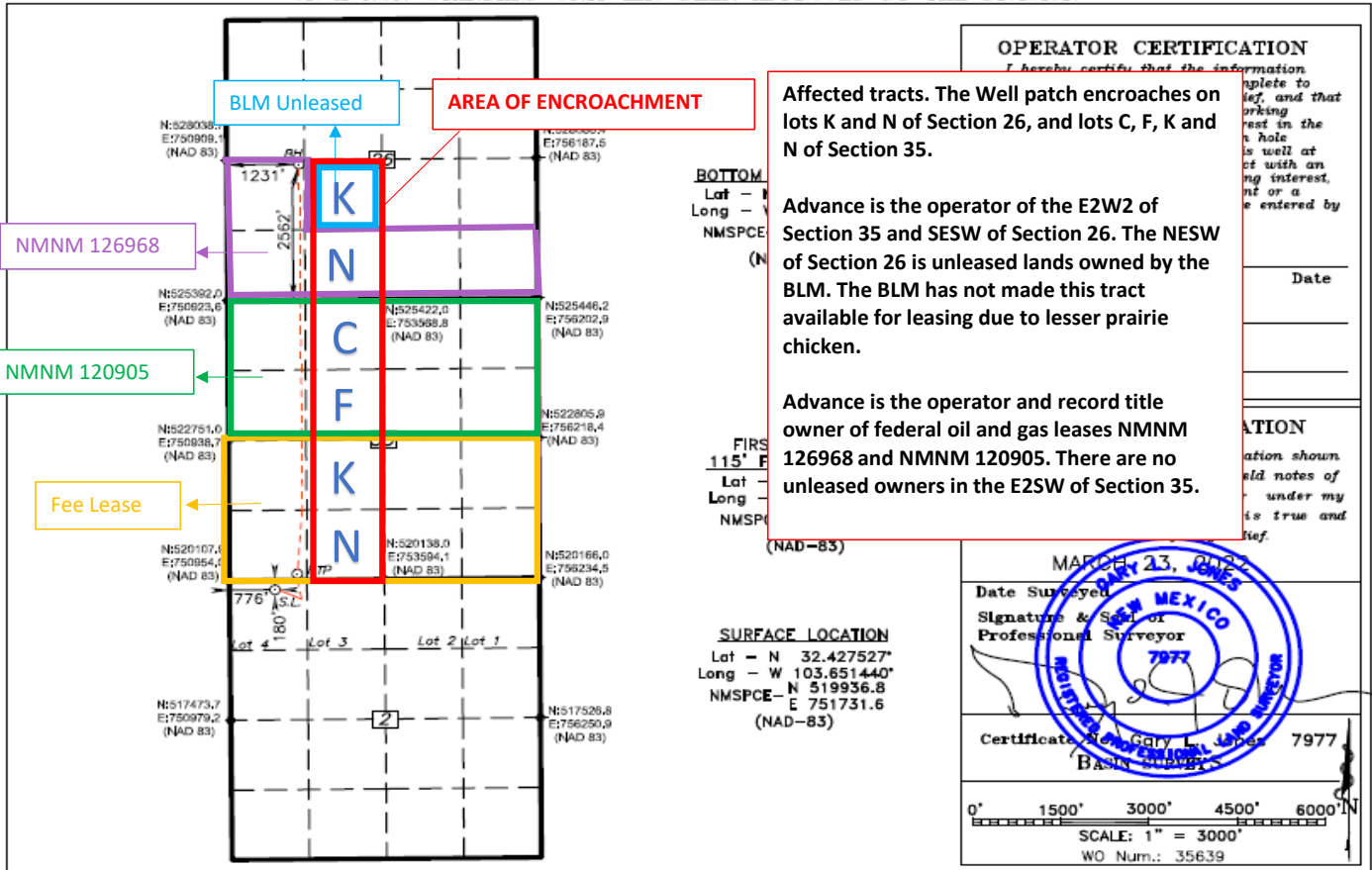

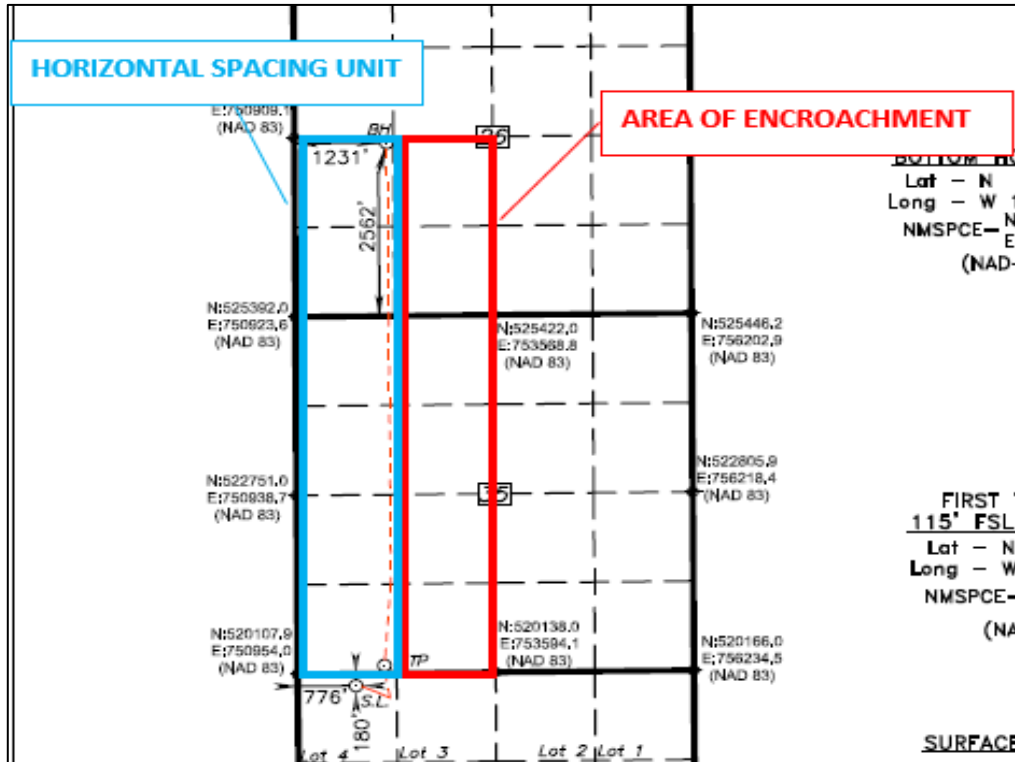
