As we discussed previously, Plains has excavated and stockpiled the impacted soil from the bottomhole portion of the excavated area at the above referenced site to approximately 19 feet below ground surface (bgs). The initial depth of the bottomhole was approximately 15 feet bgs.

Non-impacted soil that had been segregated and stockpiled during the course of the soil excavation activities was used to replace approximately 3-4 feet of the impacted soil that was removed from the bottomhole of the excavated area. Nova Safety and Environmental personnel are currently in the process of preparing the bottomhole of the excavation for the installation of a synthetic liner as per the process outlined in Section 5.0 of the approved work plan.
