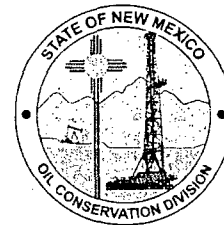



I am requesting an extension to the Jamoca SWD Administration Order SWD-1249. The well has been re-entered but failed the MIT test. We believe the squeeze holes located at 3775', may be leaking. We have a pulling unit rigged up on the well and are going to squeeze the holes on Monday the 17<sup>th</sup>.

The Administration order was issued on October 22, 2010 and expires on October 22, 2011 if the well isn't put into service by then. I am asking for an extension thru December 31, 2011. We are in the process of building the disposal battery and should have it completed by January 1, 2012.
