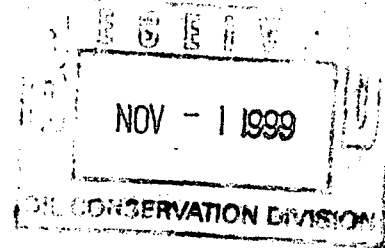

SDX Resources, Inc. is the operator of the NW State lease covering 560 acres of State Lease # 647, located in the NE/4 & SW/4 of Sec. 32, SE/4 SE/4 of sec. 29, E/2 E/2 of sec. 31 T17S R28E, and the NE/4 NE/4 of Sec. 6 T18S R28E. The NW St. # 8 well has been staked at a non-standard location of 2126' FWL and 1090' FSL of Sec. 32 T17S R28E. The location was moved to avoid existing pipe lines and a county road. This will only encroach on an internal proration unit line within the lease. SDX Resources has recently purchased the effected 40 acre tract to the Northeast of the # 8 location and owns 100 % of the working interest in this tract. SDX request that this letter serve as an application for administrative approval of the NW State # 8 location. A survey plat, a topographic map, and a lease map accompany this application. As shown on the lease map, the # 8 location chosen is necessary to maintain a consistent primary development pattern that will allow the possibility of future infill drilling (shown on lease map) to set up a secondary recovery project. Your assistance in this matter is greatly appreciated.

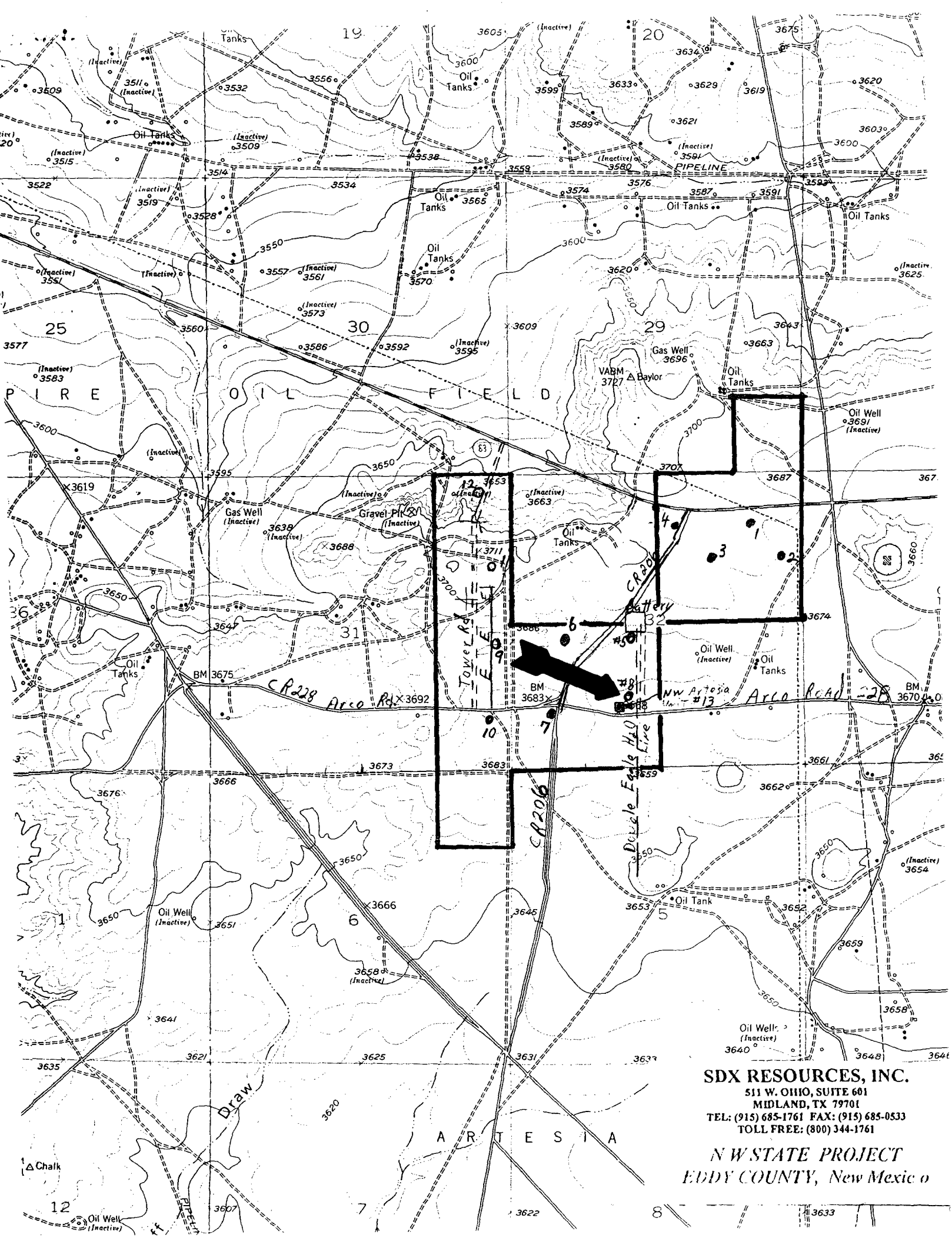
