Chesapeake Operating, Inc. ("Chesapeake") is hereby authorized to surface commingle oil and gas production from the following Pools located in Township 24 South, Ranges 31 East, NMPM, Eddy County, New Mexico,

Sand Dunes; Delaware, West Pool (**53815**)
Ingle Wells; Delaware Pool (**33745**)
Poker Lake; Delaware, East Pool (**50388**)

and from the following diversely owned wells located on Federal leases (**NMNM29234**, **NMNM63757**, and **NMNM56741**) in Eddy County, New Mexico:

[Note: The division Order No. CTB-417 issued on November 28, 1995, authorized the commingling of Lease No. NMNM29234, and NMNM63757. Now, Chesapeake Operating, Inc. requests to amend this order by adding another Lease No. NMNM56741 with wells producing from different pool. This amendment results in Order No. PLC-352].

The commingled oil and gas production shall be measured and sold at the Central Delivery Point (CDP) meter located in the NW/4SE/4 quarter of Section 9, Township 24 South, Range 31 East, NMPM, Eddy County, New Mexico. The oil and gas production from the wells is approved for off lease measurement and sales.


The oil and gas production from the wells shall be measured continuously with allocation meters before commingling with production from other wells. The allocation meters shall be calibrated semi-annually.

The producer/operator shall notify the transporter of this commingling authority.

The operator shall notify the Artesia district office of the Division upon commencement of commingling operations.

This Order supersedes Order No. PLC-352. This NUNC PRO TUNC Order was to correct the Sand Dunes; Delaware, West Pool Code from 35815 to 53815.
