Chevron U.S.A. Inc. respectfully requests administrative approval for a Non-Standard location, for the Central Vacuum Unit Well #212. This well was formerly the Vacuum Glorieta West Unit #20, which was a TA'd wellbore with no further potential in the Vacuum Glorieta West Unit unitized interval. Reviewing its salvage opportunities, the only reservoir affording the potential to recover additional hydrocarbons is the San Andres formation. If the San Andres cannot be produced, the well will be plugged and abandoned. This well is located within the unit boundary of the Central Vacuum Unit, however it is located only 221' from a quarter/quarter section line which is also the outer boundary of this Central Vacuum Unit making it an unorthodox location. All former San Andres producers in the 40 acres due north of this well (the direction of unit boundary encroachment) have been plugged and abandoned for several years.

A copy of this application has been mailed via certified mail to XTO & Exxon Mobil for their consideration.

Please find attached, a copy of the C-103 for work performed 1-25-12 through 2-03-12. The well is down and will not produce until NSL approval has been received.
