

Describe Cause of Problem and Remedial Action Taken.*

The RJ Unit #134 steel flowline ruptured due to corrosion. The flowline has been repaired.

Describe Area Affected and Cleanup Action Taken.*

Initially 10bbbls of produced fluid were released from the flowline and we were able to recover 7bbbls with a vacuum truck. The closest well location to the release is the RJ Unit #119 (API# 30-015-03146). The spill area measured 10' x 65' on the ROW from the RJU to the Robinson SWD. Tetra Tech will sample the spill site area to delineate any possible contamination from the release and we will present a remediation work plan to the NMOCD/BLM for approval prior to any significant remediation work.

I hereby certify that the information given above is true and complete to the best of my knowledge and understand that pursuant to NMOCD rules and regulations all operators are required to report and/or file certain release notifications and perform corrective actions for releases which may endanger public health or the environment.
