Pursuant to Division Rule 19.15.15.13, Apache Corporation ("Apache") respectfully requests administrative approval of an unorthodox oil well location for its proposed Washington 33 State No. 61. This well will be drilled as a development oil well in the Artesia Glorieta-Yeso Pool (96830).

The proposed Washington 33 State No. 61 will be dedicated to an existing standard 40-acre oil spacing and proration unit in the Artesia Glorieta-Yeso Pool comprising the SE/4 SE/4 of Section 33. This unit is currently dedicated to Apache's Washington 33 State Well No. 45 (API No. 30-015-40022) located at a standard well location 330 feet from the South line and 900 feet from the East line. The Washington 33 State No. 45 has been permitted, but has not yet been drilled.

The Artesia Glorieta-Yeso Pool is currently governed by Division Rule 19.19.15.9 which requires standard 40-acre oil spacing and proration units with wells to be located no closer than 330 feet to the outer boundary of the spacing unit.

The attached vicinity map shows that the proposed unorthodox well location is necessary in order to avoid an existing pipeline.

The affected offset acreage is the N/2 SE/4 of Section 33. There is currently no production from the Artesia Glorieta-Yeso Pool within these tracts however, Apache has obtained permits to drill and will develop these tracts in the near future. Please note that the Glorieta-Yeso working interest ownership between the SE/4 SE/4 and the N/2 SE/4 of

Section 33 is common throughout and is owned 100% by Apache. Consequently, notice of this application is not required to any party.

Attached is a Form C-102 showing the proposed well, spacing unit, other existing or proposed wells in the spacing unit and the affected offset acreage. Also attached are vicinity maps.

In summary, approval of the application will provide Apache Corporation the opportunity to recover additional oil and gas reserves from the Artesia Glorieta-Yeso Pool underlying the SE/4 SE/4 of Section 33 that may otherwise not be recovered by the existing or proposed producing wells, thereby preventing waste, and will not violate correlative rights.

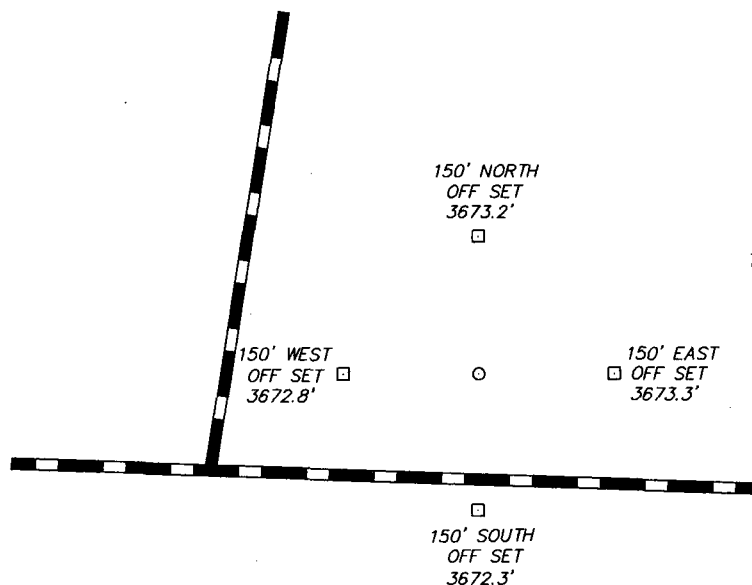

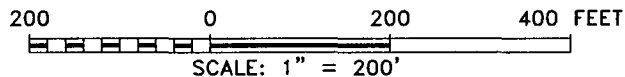
