The New Mexico Oil Conservation Division District 2 Office (OCD) is in receipt of a proposal (plan) for delineation of potential contaminants resulting from the above referenced crude oil release. The plan was prepared and submitted to OCD by Safety & Environmental Solutions, Inc. (SESI), on behalf of Holly Energy Partners.

The plan is approved with the following conditions/stipulations:

- Notify OCD District 2 office 48 hours prior to commencement of activities.
- Notify OCD District 2 office 48 hours prior to obtaining samples where the analyses will be submitted to OCD.
- Remediation per OCD rules and guidelines.
- Like approval may be required by BLM on federal surfaces.

Be advised OCD approval does not relieve the operator of liability should their operations have failed to adequately investigate and remediate contamination that may pose a threat to ground water, surface water, human health or the environment. In addition, OCD approval does not relieve the operator of responsibility for compliance with any other federal, state, local laws and/or regulations.


