Dear Ms. Bailey:

Pursuant to Division Rule 19.15.15.13, Apache Corporation ("Apache") respectfully requests administrative approval of an unorthodox oil well location for its proposed Lee Federal No. 58. This well will be drilled as a development oil well in the Cedar Lake Glorieta-Yeso Pool (96831).

The proposed Lee Federal No. 58 will be dedicated to an existing standard 40-acre oil spacing and proration unit in the Cedar Lake Glorieta-Yeso Pool comprising the NW/4 NE/4 of Section 20. This unit is currently dedicated to Apache's: i) existing Lee Federal No. 15 (API No. 30-015-32048) located at a standard well location 830 feet from the North line and 1650 feet from the East line; ii) existing Lee Federal No. 20Y (API No. 30-015-32087) located at standard well location 330 feet from the North line and 2260 feet from the East line; and iii) proposed Lee Federal No. 44 (API No. 30-015-40031) located at a standard well location 330 feet from the North line and 1650 feet from the East line.

The Cedar Lake Glorieta-Yeso Pool is currently governed by Division Rule 19.19.15.9 which requires standard 40-acre oil spacing and proration units with wells to be located no closer than 330 feet to the outer boundary of the spacing unit.

The attached vicinity map shows that the proposed unorthodox well location is necessary in order to avoid numerous surface obstructions within the NW/4 NE/4, including existing wells/well pads, electric lines and pipelines.

The affected offset acreage is the E/2 NW/4 and SW/4 NE/4 of Section 20. All three affected offset 40-acre tracts are currently being developed in the Cedar Lake Glorieta-Yeso Pool by numerous wells operated by Apache Corporation. Please note that the working interest ownership between the NW/4 NE/4 and the three affected offset 40-acre tracts is common. Consequently, notice of this application is not required to any party.

Attached is a Form C-102 showing the proposed well, spacing unit, other existing or proposed wells in the spacing unit and the affected offset acreage. Also attached is a vicinity map.

In summary, approval of the application will provide Apache Corporation the opportunity to recover additional oil and gas reserves from the Cedar Lake Glorieta-Yeso Pool underlying the NW/4 NE/4 of Section 20 that may otherwise not be recovered by the existing or proposed producing wells, thereby preventing waste, and will not violate correlative rights.




