Dear Ms. Bailey:

Pursuant to Division Rule 19.15.15.13, Apache Corporation ("Apache") respectfully requests administrative approval of an unorthodox oil well location for its proposed Tony Federal No. 37. This well will be drilled as a development oil well in the Cedar Lake Glorieta-Yeso Pool (96831).

The proposed Tony Federal No. 37 will be dedicated to an existing standard 40-acre oil spacing and proration unit in the Cedar Lake Glorieta-Yeso Pool comprising the NW/4 NE/4 of Section 19. This unit is currently dedicated to Apache's: i) existing Tony Federal No. 7 (API No. 30-015-30428) located at an unorthodox well location 230 feet from the North line and 2510 feet from the East line; and ii) existing Tony Federal No. 24 (API No. 30-015-32661) located at standard well location 990 feet from the North line and 1650 feet from the East line.

The Cedar Lake Glorieta-Yeso Pool is currently governed by Division Rule 19.19.15.9 which requires standard 40-acre oil spacing and proration units with wells to be located no closer than 330 feet to the outer boundary of the spacing unit.

The proposed unorthodox well location is necessary in order to avoid an archaeology site.

The affected offset acreage is the NE/4 NE/4 of Section 19. This tract is currently being developed in the Cedar Lake Glorieta-Yeso Pool by the Apache Corporation Tony Federal Wells No. 16 and 26. Please note that the working interest ownership between

the NW/4 NE/4 and the affected offset tract is common. Consequently, notice of this application is not required to any party.

Attached is a Form C-102 showing the proposed well, spacing unit, other existing or proposed wells in the spacing unit and the affected offset acreage. Also attached is a vicinity map.

In summary, approval of the application will provide Apache Corporation the opportunity to recover additional oil and gas reserves from the Cedar Lake Glorieta-Yeso Pool underlying the NW/4 NE/4 of Section 19 that may otherwise not be recovered by the existing or proposed producing wells, thereby preventing waste, and will not violate correlative rights.

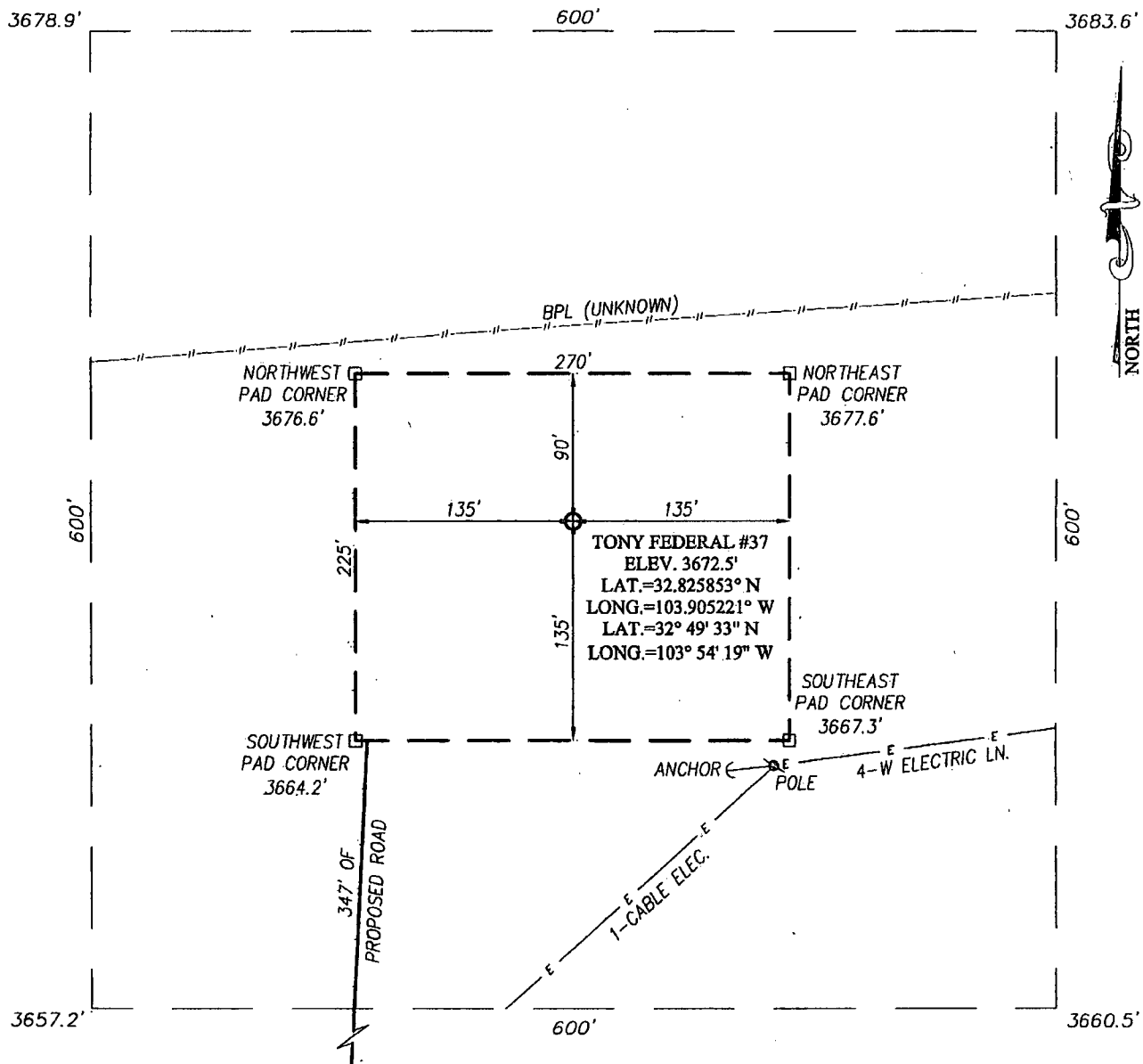

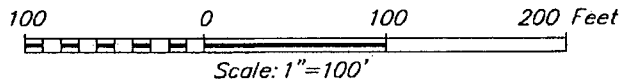

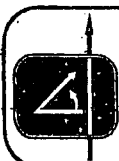
