Dear Mr. Goodwin:

The New Mexico Environment Department (Department) has reviewed the following for the subject site:

1. On-Site Investigation Report dated April, 1998. (Dames & Moore).
2. Monitor Well Replacement and Groundwater Sampling Report dated May, 2004 (Brown & Caldwell)
3. Monitor Well Sampling Report dated February, 2006 (Brown & Caldwell).
4. Monitor Well Sampling Report dated February, 2007 (Brown & Caldwell).
5. Notification of Monitor Well Plugging Activities October, 2008 (Brown & Caldwell).

The Department concurs that this site does not pose an immediate threat to public health or the environment based upon the following current site-specific conditions:

1. Monitoring wells DM-1 and DM-2 were installed in 1997 following the removal of a used oil underground oil tank adjacent to the maintenance bay. These wells (DM-1 & DM-2) became dry and were replaced by monitoring wells DM-1B & DM-2B May 2004. During monitoring well installation for wells DM-1B & DM-2B, laboratory samples collected for soil and groundwater contamination were non-detect for contaminants of concern.



2. Groundwater analyticals collected for years 2004 & 2006 from the two new wells was below laboratory detection limits for all contaminants of concern.
3. Depth to groundwater at the site is 27 feet below ground surface.
4. Soil type related to the site consists of loose silty sand to approximately 20' bgs overlying silty clay to 28' bgs. The saturated zone consists of silty sand to 40' bgs.
5. A total of six soil borings and four monitoring wells have determined the vertical and horizontal extent of soil contamination. Soil contamination indicates that the release was from the former used oil tank.
6. All monitoring wells including DM-1, DM-2 and replacement wells DM-1B and DM-2B have been properly plugged and abandoned.

Therefore, the Department is not requiring additional work at this time. However, the Department does reserve the right to require additional work in the future, should information become available which indicates that a threat to public health or the environment exists.

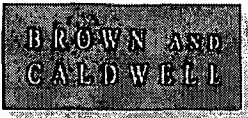

In response with the New Mexico Environment Department Petroleum Storage Tank Bureau work plan approval letter dated January 11, 2008, monitoring wells DM-1B and DM-2B at the subject facility have been plugged and abandoned. The plugging activities were performed on June 19, 2008. All work was performed in accordance with the Rules and Regulations Governing Well Driller Licensing; Construction, Repair and Plugging of Wells from the Office of the State Engineer by a New Mexico licensed water well driller. Waste associated with the plugging activities was removed and properly disposed of offsite. A copy of a letter from the drilling company that plugged the monitoring wells is attached.
