Impacted soils excavated to a depth of two (2) feet and replaced with clean soils, impacted soils hauled to an NMOCD approved facility. **Depth to Ground Water: >100' (approximately 487', per NMOSE), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0. Based on small amounts released, impacted soils removed and depth to ground water greater than 450 feet, Yates Petroleum Corporation requests closure.**
